In pursuance of Notification No. 103-BOPEE of 2019 dated 09-10-2019, vide which admissions in MD/MS Ayurveda Course in JIAR were recommended and after the last date of joining viz 15-10-2019 (04:00 p.m), the College has reported a shortfall of 8 seats. The Ministry of Ayush has extended the last date of admission for PG Courses in Ayush upto 31-10-2019 vide letter dated 30-09-2019. Therefore, the Board has decided to conduct physical counselling for filling up of 08 unfilled seats provisionally on 21-10-2019 in the Board Office, Srinagar/Jammu simultaneously. The following are eligible:-

- The cut off AIAPGET -2019 score 121 is (50th percentile) in OM and 101 (40th percentile) in reserved category.
- Reserved category candidates shall be considered only after the OM candidates are not available as there is no reservation in the said college.
- All eligible candidates upto the said cut off score shall be eligible to participate in the counselling on 21-10-2019.
- The candidates shall report in the BOPEE Office Srinagar/Jammu on 21-10-2019 at 9.30 a.m. for registration/attendance etc.
- Those candidates who have not registered earlier in the BOPEE office Jammu/Srinagar for being placed in the merit list shall also be eligible for registration.
- First timers shall have to deposit a fee of Rs.2000/- before they are allowed to participate in the counselling.
- Other terms and conditions shall remain the same as notified vide Notification No.83-BOPEE of 2019 dated 17-08-2019.
