Whereas, at the time of time of submission of online application forms for B.Ed. Kashmir/B.Ed. Special Education 2018, some candidates indicated their preferences for admission to IASE, M. A. Road, Srinagar and others for CRC, Bemina Srinagar; and

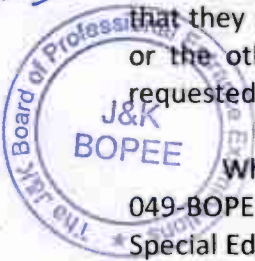
Whereas, Board vide Notification No. 026-BOPEE of 2018 dated 21-04-2018 while forwarding a list of candidates to IASE for admission in B.Ed. course 2018 had advised the candidates to submit their representation, if interested, in admission for B.Ed. Special Education in CRC, Bemina, Srinagar; and

Whereas, as a consequence of shortfall received from IASE against the select lists issued vide Notification No. Notification No. 044-BOPEE of 2018 dated 23-05-2018, Notification No. 049-BOPEE of 2018 dated 31-05-2018, Notification No. 052-BOPEE of 2018 dated 07-06-2018 and Notification No. 064-BOPEE of 2018 dated 09-07-2018 on various occasions, Board recommended additional candidates for admission including those who represented to the Board that they may be reconsidered for admission again as they could not take the same due to one or the other reason. Those whose result was withheld and submitted the documents also requested for consideration were also considered; and

Whereas, Board had also recommended 18 (eighteen) candidates vide Notification No. 049-BOPEE of 2018 dated 31-05-2018 to CRC, Bemina Srinagar for provisional admission in B.Ed. Special Education 2018 on the basis of the applications submitted by the willing candidates; and

Whereas, the CRC, Bemina Srinagar belatedly allowed the candidates to take admission after a lapse of nearly 1 ½ months in pursuance of Notification No.049-BOPEE of 2018 dated 31-05-2018. However, pursuant to the shortfall received from the CRC, the Board has recommended 15 (fifteen) more willing candidates to CRC, Bemina Srinagar on the basis of representations submitted by the candidates vide Notification No. 081-BOEE of 2018 dated 27-07-2018; and

Whereas, now some candidates have, represented that they may be considered for admission in IASE/CRC.

Now, therefore, in order to fill up the shortfall as may be received from IASE/CRC, the candidates, whose name figures in the merit list notified vide Notification No. 022-BOPEE of 2018 dated 02-04-2018 and those who have not taken admission so far and are willing to be considered for admission, may indicate their willingness to be recommended for admission in CRC or IASE as the case may be, by submitting an application in BOPEE Office Srinagar/Jammu so that consequent upon shortfall received, if any, such eligible and willing candidates could be considered for allotment of seats on merit cum preference in IASE/CRC. **The candidates can submit their application on Plain Paper up to 8<sup>th</sup> August, 2018 (3.00 P.M.) in the BOPEE office, Srinagar/Jammu after which no application will be entertained.** The shortfall, if any, in IASE/CRC will be filled only and only from the candidates, who submit or have submitted their applications up to the prescribed date.

**Note:-**

The tentative fee in CRC is Rs.24,000/- per annum and Rs. 10,530/- in IASE per annum as notified earlier also in the Information Brochure.
