Subject:- Un-necessary queries from the candidates of NEET UG, 2018 about Provisional State Merit List.

NOTICE NO. 056-BOPEE OF 2018 DATED 27-06-2018

It has been observed that some candidates/persons approach the Board for seeking the details about the State Merit List, which list has already been put in the public domain vide Notification No. 057-BOPEE of 2018 dated 23-06-2018 read with Notification No. 060-BOPEE of 2018 dated 26-06-2018. The candidates/persons desirous of making assessment of their merit viz-a-viz others should do so by analyzing the State Merit List and not by approaching the BOPEE as Board cannot share any information with any candidate(s). Some persons start entering into un-necessary arguments resulting in wastage of time of the Board, apart from causing harassment to the staff.

The Board reiterates that the relevant information about the State Merit List has been put into the public domain vide Notification No. 057-BOPEE of 2018 dated 23-06-2018 read with Notification No. 060-BOPEE of 2018 dated 26-06-2018 and no other information can be shared with the candidates/persons approaching the Board. Board had already given two days time to the candidates make representation vide above Notifications and no representation has been received so far, which would merit any disposal.

However, in case any candidates faces any difficulty in filling up of online preference form, like resetting of password, editing preferences, payment related issues etc, he/she can approach the Board alongwith proof of his/her identity and make a written request so that Board facilitates such candidate accordingly. This facility can be provided to the aspiring candidate only and not to his/her proxy, whosoever. As of now the Board has facilitated large number of the candidates by providing the required assistance as could be provided under rules to them.

Note:-


Board shall not hesitate in reporting the matter to the relevant competent authorities for action against any person, who try to disrupt the process, for appropriate necessary action as may be required under law.
