Subject: Joint Counselling- Eligibility for filling up of Online Preference Form by PG/Diploma/MDS candidates 2017.

It is hereby notified that following shall be eligible for filling up of Online Preference Form for allotment of seat/college for admission to MD/MS/ PG Diploma/ MDS 2017.

1. All MD/MS/PG Diploma candidates, who have qualified NEET 2017 and presented themselves for deposition of documents /certificates before the Board w.e.f 02-02-2017 to 16-02-2017 pursuant to Notification dated 27-01-2017 and 12-02-2017.
2. MDS candidates (three times the number of candidates) who have qualified NEET 2017 and presented themselves for deposition of documents /certificates before the Board w.e.f 02-02-2017 to 16-02-2017 pursuant to Notification dated 27-01-2017 and 12-02-2017, with the following cut off merits:-

Open Merit	831.4098
RBA	761.0045
SC	758.7261
CDP	746.7177


This shall be further subject to clarification as may be provided by the Government in respect of Difficult Area/Rural Service.

It is, however, clarified that the candidates are being called more in numbers than the actual numbers of seats only to ensure that no seat remains unfilled but while filling up the Online application form the candidates need to assess their merit position viz-a-viz seat matrix notified by the Board already and take a decision of their own. The mere filling up of the Online Preference form shall not confer any right on any candidate to get selected, which shall purely depend upon his/her merit/Preference indicated by him/her for seat/college and also subject to the eligibility. Any candidate found ineligible at any stage of admission shall be disqualified from the process without any notice.

Since the joint counselling of the candidates has been scheduled for 4<sup>th</sup> and 6<sup>th</sup> of March 2017 at Jammu/Srinagar respectively, the candidates desirous of participating in such counselling session shall reach the venue of the counselling as already notified atleast 2



hours earlier i.e 10.30 AM before the commencement of the session for registration purposes. Only such candidates who fill in the registration form will be allowed entry in the hall.
