**Subject:- Second round of counselling (physical) of NEET UG, 2018.**

## Notification No.070-BOPEE of 2018 Dated 17-07-2018

Consequent upon completion of first round of counselling of NEET UG 2018, the second round of counselling (physical) for filling up of the vacant seats in Government/Private Colleges shall be conducted w.e.f. 25-07-2018 to 27-07-2018 in the Board Office Jammu/Srinagar as per the following schedule:-

S. No.	Date	Remarks
01.	25-07-2018 upto 1.00 P.M	Filling up of unfilled category seats.
	25-07-2018 at 1.15 p.m.	Conversion of unfilled category seats, if any, into OM and filling up of the OM seats, simultaneously for Government/ASCOMS and Diploma in Dental Hygiene in GDC, Srinagar.
02.	26-07-2018	Filling up of unfilled seats, if any, in Government/ASCOMS/IDS, HMQ seats in ASCOMS and DDH seats in GDC, Srinagar
03.	27-07-2018	Filling up of any other seat(s) remaining vacant on 26-07-2018 and NRI quota seats in ASCOMS and IDS/DDH in GDC, Srinagar.

Five seats of Diploma in Dental Hygiene in GDC, Srinagar (OM=3, STGB=1 & RBA =1) shall also be filled up during the second round of counselling.

The candidates:-

- i) allotted Government/Private Colleges in the first round of online counselling but who have not joined because of one or the other reason shall be given an opportunity to compete against the Government seats on the basis of merit cum preference;
- ii) who were allotted seats in ASCOMS, but did not join, will ordinarily not be considered for re-allotment in the said College unless they produce requisite documents in support of their ability to meet the financial requirements of the College as it has been noticed that many candidates have failed to take admission in view of their inability to pay the fee etc;
- iii) who figure in the PSML but have not participated in the first round of online counselling shall be eligible to participate in the physical round of counselling;
- iv) who did not get a seat during online round of counselling shall also be eligible to participate in the counselling;
- v) desirous of participating in the counselling process shall report in the BOPEE Office, Jammu/Srinagar for registration on their respective date of counselling at 9.00 a.m;
- vi) participating for the first time shall have to deposit a fee of Rs.1500/- through POS machines available in BOPEE Offices before they are allowed to participate in the counselling;
- vii) shall have to submit fresh preferences on their respective date of counselling;
- viii) are advised to go through the Information Brochure. Other conditions mentioned there but not mentioned above shall apply.

Note:- A) The candidates who could not register themselves online and do not figure in the State Merit List are given an opportunity to register themselves with the BOPEE Office upto 23<sup>rd</sup> of July, 2018 so that they are assigned rank and considered for allotment of seats on the basis of their merit cum preference during the second round of counselling.
