**Subject:-** Second round of counselling (physical) of NEET UG, BUMS/BAMS/BPT, 2018.  
**Reference:-** (i) Notice No. 78-BOPEE of 2018 dated 28-08-2018;  
(ii) Notification NO. 103-BOPEE of 2018 dated 10-09-2018.

**Notification No. 105-BOPEE of 2018 Dated 17-09-2018**

It is hereby notified that last date for joining the colleges under AYUSH/BPT Courses for which admissions were made vide **Notification NO. 103-BOPEE of 2018 dated 10-09-2018** is hereby extended **upto 19-09-2018 4.00 p.m.** The Colleges shall submit the shortfall positively on the same day upto 5.00 p..m.

Consequent upon the above and after completion of first round of counselling of **NEET UG, BUMS/BAMS/BPT, 2018**, the second round of counselling (physical) for filling up of the vacant seats in Government/Private Colleges shall be conducted on **24-09-2018** in the Board Office Jammu/Srinagar as against the seats that may be reported unfilled due to non joining and shall be notified separately. However, as on date following seats are available to be filled up:-

The candidates:-

- allotted Government/Private Colleges in the first round of online counselling but who have not joined because of one or the other reason shall be given an opportunity to compete against seats on the basis of merit cum preference;
- who figure in the Provisional State Merit List (PSML) in terms of Notice No. 78-BOPEE of 2018 dated 28-08-2018 but have not participated in the first round of online counselling shall be eligible to participate in the physical round of counselling (the candidates who have registered themselves during NEET MBBS/BDS counselling process shall also be eligible in terms of the said Notification) ;
- who did not get a seat during online round of counselling shall also be eligible to participate in the counselling;
- desirous of participating in the counselling process shall report in the BOPEE Office, Jammu/Srinagar for registration on the date of counselling viz 24-09-2018 at 9.00 a.m;
- participating for the first time shall have to deposit a fee of Rs.1500/- through POS machines available in BOPEE Offices before they are allowed to participate in the counselling;
- shall have to submit fresh preferences on the date of counselling;
- are advised to go through the Information Brochure. Other conditions mentioned there but not mentioned above shall apply.

**Note:-**

- (A) The candidates should weigh their options of allotment of seat carefully before formally approaching the Board for participation in the second round of counselling with a view to avoid un-

necessary rush of candidates during the process of counselling. Since the rank has been notified earlier and the availability of seats is now notified in advance, therefore, the candidates can better visualize the prospect of allotment of seat;

(B) The seats in Jammu Institute of Ayurveda & Research(JIAR), Jammu , which have not been filled during the first round of online counselling in light of Government of India, Ministry of AYUSH communication dated 13-08-2018 shall continue to remain on hold till a clarification is received from the Ministry. Therefore, these seats shall not be filled up during the second round of counselling unless otherwise provided by the Government of India;

(C) The candidates are requested to remain in touch with the BOPEE website [www.jkbopee.gov.in/www.jakbopee.org](http://www.jkbopee.gov.in/www.jakbopee.org). for seat matrix etc., which shall be uploaded after receipt of the shortfall from the Colleges.
