Online Applications are invited from permanent residents of J&K State who are eligible and desirous of appearing in the Common Entrance Test (CET) for admission to BE./B.Tech. Engineering Courses for the academic session 2018-19. The selection of the candidates shall be governed by the J&K Board of Professional Entrance Examination Act, 2002 and the Rules and Regulations issued thereunder; JK Reservation Act, 2004 and the Rules issued thereunder and any other guidelines, which are available on the official websites of the BOPEE <http://www.jakbopee.org> / www.jkbopee.gov.in

7. The candidates, in their own interest, are advised to go through the Information Brochure before filling up of Online Application Forms. Board shall not be responsible for any act of omission or commission in filling up of the Online Application Form by the candidate. It shall be presumed that the candidate has gone through the information contained in the e-Information Brochure and has agreed to follow the conditions contained therein. No candidate can claim any alteration in conditions which have been incorporated in the e-Information Brochure and notified in advance.
8. The candidates are further advised to remain in touch with the BOPEE website (s) www.jkbopee.gov.in / www.jakbopee.org . The Board does not undertake any responsibility for any delay caused in publication of Notices/ Notifications in the Print Media (Newspapers) as delay, if any, in such publication(s) is not within the control of the Board, notwithstanding that the Board notifies the same on the official website(s) and for publication simultaneously on the date of issue of the said Notifications/Notices etc.
9. The examination may be conducted Online / Offline as may be decided by the Board.

Online Application forms:

Application Forms have to be submitted Online only through BOPEE websites www.jkbopee.gov.in / www.jakbopee.org (through URL's/ Links provided for this purpose) from **1st February to 3rd March, 2018**. The payment of Rs. 800/- (Rupees eight hundred) only as fee is to be made also online through the integrated "Bill Desk Payment Gateway" which can be used to make payment with any national Credit Card/Debit Card/Net Banking. The procedure for filling Application Form and eligibility etc. of the candidates has been given in detail in the e-Brochure. The applicants must

necessarily, in their own interest, go through this e-Brochure before attempting to fill up the online Application Form.

The applicants are advised to fill the online Application Forms on their own or through a responsible person. The applicants can also avail of services at Common Service Centres of J&K State for filling up online Application Forms at nominal charge. They can also avail of the services at any National Informatics Centre located at the office of the Deputy Commissioner of the concerned District.

Submission of Online Application Forms:

The interested candidates have to upload the following original scanned documents/certificates in PDF format with size from 100-200 KB along with the Application Form:-

- (i) Permanent Resident Certificate;
- (ii) Qualifying marks certificate; (where result is declared)
- (iii) Date of Birth Certificate; and
- (iv) Reserved category certificate, if any, (including Sports Certificate/ TFW certificate) on the prescribed Proforma. (Duly renewed where ever applicable)

Note:-

1. The candidates can change/ modify their online Application Form at any time before it is submitted online. However, for any subsequent modifications, if required, the candidates should approach the BOPEE office Srinagar/ Jammu. They are advised, in their own interest, not to share their login details with any other person, lest he/she may get an opportunity to change important details in the Application Form. They can check the status of their Application Form on the official website(s) of the BOPEE. If any form is not confirmed for want of required information, the candidate concerned must report in the BOPEE office Srinagar or Jammu by or before **3rd March, 2018** failing which his/her application form shall be rejected.
2. Candidates shall also have to upload their photograph, signature and thumb impression images in JPEG format and size within the range of 10-50 KB as given in the instructions in the e-Information Brochure and on the BOPEE website(s).
3. The candidates must, after filling up all the required entries, ensure that their online payment has been successfully made and all the requisite documents have been uploaded in specified format/size. Mere downloading of the Application Form does not mean that the candidate has submitted his/her Application Form successfully. Candidate should ensure that he/she keeps checking the status of his/her online application forms until it is scrutinized by the Board and approved/ accepted.
4. For any help / assistance candidates may call "Help Desk" numbers during office hours of the working days.

Eligibility

The Applicant must:

- be permanent resident of J&K State as defined in section 6 of the Constitution of the J&K State;

- Have passed Hr. Sec. Part-II (12th/10+2) or an equivalent examination from a recognised statutory Board/University. The candidates appearing/appeared in 12th class examination can also apply for the Entrance Test;
- Be at least 17 years old on 31st December of the relevant year (2018) and have passed 10+2 or equivalent examination with at least 50% marks in 10+2 examination for Open Merit Category candidates, including the Children of Defence Personnel, Children of Para-Military Forces, Children of State Police Personnel and candidates possessing outstanding proficiency in Sports and 40% marks for the candidates belonging to SC/ST and other Backward Classes.
- Have passed 10+2 examination with English, Physics, Chemistry and Mathematics as their elective subjects in case of admission to B.E/B.Tech. Engineering Courses.
- The candidates appearing/appeared in 10+2 (12th Class) annual examination can also apply to appear in CET-2018. However, such candidates have to produce their original marks cards before or at the time of filling in Online Form for counselling/selection, if they figure in the list of the candidates qualified or called for counselling as the case may be. If a candidate has been called for counselling but has failed to secure required percentage of marks in the qualifying examination, he/she shall not be considered for admission.
- The candidates applying under TFW category are open merit candidates. They must fulfil eligibility conditions prescribed for open merit candidates.

Note: *There is no upper age bar for appearing in the Entrance Test for admission to Engineering Courses, both in Government and Private Colleges.*

Instructions:

- a) No under process certificate will be accepted;
- b) The information provided by the candidates in the online Application Form cannot be verified from the original documents by the BOPEE officials before admission of candidates. The information on the Application Form downloaded page or on the Admit Card of candidate shall in no case be construed as an acceptance of such information/category certificate by the BOPEE. Therefore, if at any stage, it is found that a candidate has provided false or incorrect information in respect of any eligibility condition(s), his/her candidature will be cancelled without any further notice;

Warning:

The candidates are warned not to resort to any unfair / fraudulent means or act of impersonation at the time of Entrance Test or upload any objectionable material including a photo of any object, other than his/her own photograph while submitting the online form. In case, a candidate is found taking recourse to such acts, criminal prosecution shall be launched against him/her and his/her abettors. He /she shall be permanently debarred from appearing in the entrance Test in future.

Original Documents required to be submitted in the Institution at the time of Admission:-

- a) Marks certificate of the qualifying examinations;
- b) Date of birth (Matriculation / Secondary School Certificate) from the Board of School Education;
- c) Permanent Resident Certificate; and
- d) Category Certificate, if any.
- e) Any other document as may be required by the Institution.

Note:-

- (i) The sports category candidates have to indicate their sports category on the Application Form. They are also required to submit their Sports certificate(s) in the office of the Secretary, J&K State Sports Council Jammu / Srinagar for determining their sports points which will be afterwards officially forwarded by the Council to the BOPEE. The BOPEE, however, shall not be responsible for non-



inclusion of any candidate in the list forwarded by the Sports Council or for their delay in submission of sports points to the BOPEE.

(ii) The candidates having more than one reserved category certificate can get benefit of only one category indicated and uploaded along with the Application Form which in no case shall be changed afterwards. The candidate, whose category certificate has not been found valid, will be considered in open merit, if otherwise found eligible without any further notice.

Roll No Slip/Admit Card:

The Notification for downloading of online/electronic Admit Card will be issued separately. The candidates, who fail to download their admit card, must report in the office of the BOPEE Srinagar/Jammu immediately. The electronic admit card will indicate time, Venue and schedule of the Entrance Test. The electronic Admit Card shall have the space for photograph of the candidate. The candidate has to affix his/her photograph which should then be attested by a Gazetted officer. A candidate will in no case be allowed to appear in the Entrance Test without attested photograph on the Admit Card. The candidates are advised to remain in touch with the official Website(s) of BOPEE for updates for Centre notification and for other important information relating to Common Entrance Test-2018. The candidates will receive SMS and / or e-mails for updates at various stage during the entire process of filling up of the online application form till selection of candidates, if applicable.

Issuance of Admit Cards and Date of Test:

Information with regard to availability of Online Admit Cards, Venue and Time of the Common Entrance Test will be issued separately in due course of time. The Entrance Test will be held on 22nd April (Sunday), 2018.


Note-1:-
