



Subject:- Filling up of vacant seats of BPT—Sixth round of counselling.
Reference:- Notification No. 118-BOPEE OF 2018 DATED 01-11-2018.

Consequent upon receipt of shortfall from the Jammu College of Physiotherapy (JCP), Jammu vide communication No. JCP/2018/350 dated 10-11-2018 during the fifth round of counselling held on 06-11-2018 in pursuance of Notification No. 118-BOPEE OF 2018 DATED 01-11-2018, the sixth round of counselling of these seats shall be held on **26-11-2018** physically at Jammu and Srinagar offices of the BOPEE simultaneously. The eligible and willing candidates shall report in the BOPEE Offices on the said date at 10.00 a.m.

1. Number of seats to be filled up = 10
2. Cut off NEET score = 65

Further as already notified:-

- (i) **the BPT course does not fall under AYUSH courses, therefore, the cut off merit for admission to BPT courses has been reduced to 65 NEET score;**
- (ii) The candidates, who have already registered earlier can also participate in the counselling and those who have not registered but are willing to be considered for admission to BPT course can also participate in the counselling on the said date. However, the candidates who have not registered online earlier shall have to do so up to **26th of November, 2018 up to 10:00 AM** in the Board office at Srinagar / Jammu. They shall be allowed to participate in the counselling only on production of all documents in original at the time of registration and on payment of **Rs. 1500/-** through POS machine in the BOPEE office Jammu/Srinagar on the said date;
- (iii) The seats becoming available during the process of counselling shall also be filled up during the same process;
- (iv) The candidates shall also have to register themselves for purpose of attendance on **26th of November, 2018 between 10:00 AM to 11:00 AM** after which they will be allowed to participate (physically) in the counselling process and the seats shall be allotted on merit cum preference.
