**Subject: - Filling up of vacant seats BAMS UG/PG seats in JIAR in compliance of orders of the Hon'ble High Court at Jammu dated 15-01-2019 in IA No. 1/2019 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research (JIAR) Vs Union of India & Others.**

## NOTIFICATION No. 005-BOPEE OF 2019 DATED 21-01-2019

In compliance and with due deference of the orders of the Hon'ble High Court dated 15-01-2019 in IA No. 1/2019 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others, it is notified that the counselling of the unfilled seats of BAMS UG & MD/MS (Ayurveda) in JIAR, Jammu for the year 2018 shall be conducted on **28-01-2019** in the Board Office at Srinagar/Jammu simultaneously as under:-

1. BAMS (UG) seats (OM= 22, P&B = 04)
2. MD/MS (Ayurveda) Seats (OM= 03 Kriya Sharir)

**The eligibility for counselling for UG Courses shall be as notified already vide notification No. 121-BOPEE of 2018 dated 22-12-2018 as under:-**

- i) OM NEET score 86 and above;
- ii) Reserved categories NEET score 67 and above.

The admission shall be only for BAMS in JIAR, Jammu

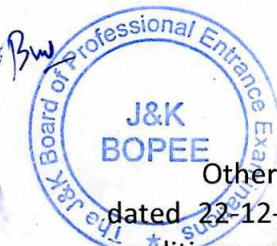
### **The eligibility for PG Courses:-**

Only such candidates, who are the State subjects of J&K, shall be eligible to compete with the following score obtained in the Test conducted by the AIAPGET, 2018 :-

- i) OM = 30 marks ( 50<sup>th</sup> percentile)
- ii) SC/ST = 25.5 marks (40<sup>th</sup> percentile)
- iii) RBA/ALC/OSC = 27.5 marks (45<sup>th</sup> percentile)

Other conditions shall remain same as notified vide Notification No. 121-BOPEE of 2018 dated 22-12-2018, Notification No. 125-BOPEE of 2018 dated 31-12-2018 and such other conditions as notified from time to time. The candidates are advised to go through the relevant notifications / notices on the subject available on the website of the BOPEE [www.jkbopee.gov.in](http://www.jkbopee.gov.in) .

As already notified, the permission granted by the Ministry of AYUSH, Government of India to JIAR, Jammu for running the said courses has been withdrawn vide Order dated 26-09-2018 in view of various shortcomings and deficiencies as mentioned in the said order, which



order has been challenged by the JIAR before the Hon'ble High Court at Jammu in OWP No. 2208/2018 and the interim directions have been passed in the said writ petition including stay granted on order dated 26-09-2018, therefore, the counselling shall be purely provisional and subject to such other orders as may be passed by the Hon'ble Court/final outcome of the writ petition No. 2208/2018 pending before the Hon'ble High Court at Jammu.
