#### PUBLIC NOTICE NO. 007-BOPEE of 2018 DATED 05-02-2018

and oligible candidates for appearing in PET examination, 2018 vide its Notification No. 146-BOPEE of 2017 dated 29-12-2017 read with Notification No. 003-BOPEE of 2018 dated 31-01-2018. The last date for submission of forms is 17-02-2018. The candidates who have not applied so far but are willing to do so may apply accordingly. The important details of the Notification No. 146-BOPEE of 2017 dated 29-12-2017 are re-produced as under:-

#### "Eligibility

- 1. The Applicant must:
- a) be a permanent resident of J&K State as defined in Section 6 of the Constitution of the J&K;
- b) have passed 10<sup>th</sup> Class Examination from a recognized Board/Institution according to;
- have obtained not less than 40% of marks in aggregate in the qualifying examination in open merit and not less than 37% of marks in aggregate in any reserved category.
- The candidates appearing/ appeared in the qualifying examination are also eligible to appear in the Entrance Test but they have to upload/submit the qualifying examination certificate within the prescribed date to be notified separately.

# Instructions:

- a) No under process certificates will be accupted; su
- b) The information provided by the candidates in the online Application Form cannot be verified from the original documents by the BOPEE officials before admission of the candidates. The information on the Application Form down loaded Page or on the Admit Card of candidate shall in no case be construed as an acceptance of such information/category certificate by the BOPEE. Therefore, if at any stage, it is found that a candidate has provided false or incorrect information in respect of any eligibility condition, his/her candidature will be cancelled without any further notice;

# Warning:

a) The Candidates are warned not to resort to any unfair/fraudulent means or act of impersonation at the time of Entrance Test or upload any objectionable material including a photo of any object, other than his/her own photograph while submitting the online form. In case, a candidate is found taking recourse to such acts, criminal

permanently debarred from appearing in the Entrance Test in future.

b) Any candidate uploading image of an object other than his/her own photograph shall be Bodisqualified from appearing in the Examination(s). Besides action as warranted under law shalls be taken against such candidate.

# Original Documents Required to be submitted in the Institution at the time of Admission:

- a) Marks certificate of the qualifying examination;
- Date of Birth (Matriculation Certificate/Secondary School Certificate) from the Board of School Education;
- c) Permanent Resident Certificate; and
- d) Category Certificate.

#### NOTES:

- 1. The sports category candidates have to indicate their sports category on the Application Form and upload volid sports certificate(s) issued by the Competent Authority. They are also required to submit their Sports certificate(s) in the office of the Secretary Sports Council for determining their sports points which will afterwards be officially forwarded by the Council to the BOPEE. The BOPEE, however, shall not be responsible for non-inclusion of any candidate in the list forwarded by the Sports Council or for their delay in submission of sports points to the BOPEE.
- II. The candidates having more than one reserved category certificate can get benefit of only one category indicated and uploaded along with the Application Form which in no case shall be changed afterwards. The candidate, whose category certificate has not been found valid, will be considered in open merit, if otherwise found eligible, without any further notice."
