Subject:- Bogus Email addresses prepared at cyber cafes during filling up of Online Application forms for PET/CET 2018.


**Public Notice No. 009 –BOPEE of 2018 dated 08-02-2018**

During the scrutiny of the documents /data of the candidates applying for PET/CET admission examination 2018 it has been observed by the Board that many emails are recorded by the cyber cafes which actually do not exist or are not generated as a consequence whereof such candidates fail to receive the messages through such emails both auto and otherwise . Besides being an unlawful action, on the part of the cyber cafes/candidates, it causes hardships to the candidates as well as they do not remain updated on the issues.

The matter has been viewed with concern by the Board and it is accordingly impressed upon:

1. The Cyber Cafes to ensure that while assisting the candidates in filling up the forms proper email address of the candidate should be generated;
2. Such cyber Cafes should be careful and not to misguide / mislead the candidates. Board shall be within its rights to initiate action against such cyber cafes;
3. The candidates, in their own interest, should ensure that they do not furnish any false information/address as such an action can lead to their disqualification. Besides they would not be in a position to update themselves on various issues;
4. The candidates who have not generated the email address should do so in their own interest.

It is further notified that the Board shall not be responsible for any lapse on the part of the candidate in not furnishing the complete information while filling up of the application form.
