Subject: - Submission of deficient documents/updation of category status of CET candidates 2019.

NOTICE NO. 052-BOPEE of 2019 DATED 28-05-2019

While notifying the result of CET examination 2019, vide Notification No. 40-BOPEE of 2019 Dated 17-05-2019, the candidates whose result was withheld for want of deficient documents were given an opportunity to submit such documents up to 24-5-2019. Many candidates have failed to submit the deficient documents within the prescribed date and as such their result continues to remain withheld and as such cannot participate in the counselling process.

Further Board has been receiving requests from the candidates to allow them to update their category status as they could not produce the same or upload the documents for one or the other reason.


The matter has been examined and considered by the Board and it has been felt that it would be expedient for the Board to avoid hardships caused to the candidates due to non deposition of the deficient documents and also non updation of the category status.

Now, therefore in exercise of the powers conferred under Regulation 40 (III) of the BOPEE regulations it is hereby notified that:-

1. The candidates, whose CET result 2019 is withheld for want of deficient documents, may submit the same to the BOPEE up to 01-06-2019 in person in the Board office at Srinagar/Jammu. The candidate shall be required to produce original documents also along with a set of deficient documents duly attested by the candidates.
2. The candidates who wish to update their category status including (Income certificate for purpose of tuition fee waiver) may also submit the documents in person upto 01-06-2019 in the same manner as prescribed above.
3. No certificates or documents shall be received after 01-06-2019 (2PM).

Other terms and conditions shall remain same as notified vide Notification No. 40-BOPEE of 2019 Dated 17-05-2019.
