**Notice No. 78-BOPEE of 2019 dated 14-08-2019**

It is hereby notified for the information of candidates aspiring to seek admission in AYUSH/BPT courses in Jammu and Kashmir that:

- The last date for filling up of online preferences which was fixed as 14<sup>th</sup> August 2019 vide Notification No. 77-BOPEE of 2019 dated 01.08.2019 is hereby extended upto 22.08.2019.
- The candidates who have not made the online payment of fee of Rs. 1500/- during the NEET UG counselling may do so after locking up of the preferences.
- As the Government of India, Ministry of Ayush has now granted conditional permission to Jammu Institute of Ayurved and Research, Jammu (JIAR) vide their letter No. Z-14014/65/2019-EP(1) Dated 07.08.2019, the 90 seats in the Institute including those under management quota shall also be filled up during the present online counselling process.
- 25 BPT seats in Composite Research Centre, Srinagar (CRC) shall also be now filled up during the current online counselling process.
- Seat matrix shall be updated in due course of time. However, the reservation in CRC shall be as per applicable reservation on the State.
- In order to enable the candidates to update the preferences, preferences of all those who have locked the same shall be unlocked in due course of time. However, in case of any difficulty the candidates can approach the Board office Srinagar/Jammu.
- The cut off merit shall remain the same as notified vide Notification No. 77-BOPEE of 2019 dated 01.08.2019. The other terms and conditions as notified in the said notification shall also remain the same.

Note: The conditional permission letter in favour of JAIR dated 07.08.2019 from the Ministry of Ayush shall also be available on the BOPEE website in due course of time for facilitation of the candidates.
