Subject:- **Representations regarding receipt of admission fee by the Colleges.**


Sir/Madam,

The Board has received representations from many candidates, who approached the Office in person that due to prevailing situation they have not been able to deposit the fee in the colleges allotted to them for admission in BE/B. Tech Courses, 2019 notwithstanding allotment of seats to them/upgradation by the BOPEE. The Board had earlier considered the matter and vide communication No. BOPEE/Exam/CET-04/2019 dated 16-08-2019 allowed the colleges to admit such candidates to complete the formalities etc., who have been allotted seats/upgraded vide Notification No. 75-BOPEE of 2019 dated 31-07-2019 but could not join upto the stipulated time. Further, the Principal, GCET, Ganderbal, Kashmir in person came to Board Office, Srinagar to discuss the matter with the Chairman and intimated that he had not received the communication dated 16-08-2019 due to the prevailing situation. The matter has been further examined in light of over-all parameters and it has been decided that:-

- (a) The candidates, who have been allotted seats vide Notification No. 75-BOPEE of 2019 dated 31-07-2019 read with other communications on the subject shall be allowed to complete the formalities **upto 26<sup>th</sup> August, 2019 (4.00 p.m.)**. However, no new candidate shall be admitted by the Colleges at their own level under any circumstances;
- (b) In case online portals for receipt of fee are not functional, the Colleges may receive the fee either through cheques or by cash, which should, however, be remitted into the account immediately;
- (c) In case of upgradation of candidates, the colleges should not insist for payment of the fresh fee as of now, but the candidate should submit a proof that he/she has already deposited the fee in the colleges, which was allotted to him/her earlier based on which his/her upgradation has taken place. The issue of reconciliation of fee will be undertaken by the colleges separately and such colleges where from the candidate has been upgraded shall be bound to transfer the fee of the candidate to the new college allotted under an intimation to the Board. The college shall work out the details of such candidates and also apprise the Board accordingly. However, in case any candidate is willing to make the payment to the College without waiting for transfer of his fee, the College may entertain such fee also but in such case the College initially allotted shall be duty bound to refund the fee to the candidate on production of the receipt of fee deposited by him/her in the college allotted after upgradation; and
- (d) The Colleges, who have retained the documents of candidates at the time of admission should release the same in case of candidates upgraded, but the Colleges, in which candidates have been upgraded will entertain the receipt of the documents deposited by the candidates in the previously allotted College to ensure that the candidates do not suffer.

It is accordingly, requested that further necessary action may be taken and the Board be kept apprised about the same. The shortfall, if any, may be communicated to the Board Office on **26-08-2019 (upto 5.00 p.m.)**. It is further reiterated that under no circumstances shall the Colleges admit any fresh candidate at their own level and above dispensation has been worked out purely in case of such candidates who already been allotted/upgraded seats by the Board within the time-frame but could not fulfill the formalities due to prevailing situations.
