Now, therefore, in partial modification of Notification No. 85-BOPEE of 2019 dated 23-08-2019 the admission of Miss Khairun Nissa NEET Roll No. 250203719, NEET Score 133, NEET Rank 707201, Category STK figuring at S.No. 304 of the said Notification is hereby withdrawn and consequent upon the said withdrawal Miss Tohira Khatoon, NEET Roll No. 250100617, All India Rank 291085, Marks Scored 280, State Rank 2961, Category STK is allotted the BAMS seat in STK category in GAMC, Jammu. The College shall take further necessary action accordingly.
