Following seats have remained unfilled in CRC and JCP for BPT courses after completion of the counselling held on 26-09-2019 as also management quota seats of JCP were not filled up during previous rounds of counselling as notified from time to time:-

These seats shall be filled up through physical counselling simultaneously in the Board Office at Srinagar/Jammu on **03-10-2019**. Since the BPT does not fall under AYUSH courses as notified earlier also and, therefore, after due consideration the Board has decided to reduce the cut off merit for being eligible for admission in BPT Course upto 107 and 86 in respect of OM and reserved category candidates respectively for CRC. The cut off score for BPT in JCP shall, however, be 107.

Willing and eligible candidates with the above cut off score in NEET UG shall report in the BOPEE Office for counselling on **03-10-2019 at 9.30 a.m.** initially for registration/attendance and for subsequent counselling and allotment of seats on the basis of merit cum preference.
