The Composite Regional Centre, Bemina has informed that ten seats have remained unfilled for admission to B.Ed. Special Course 2019-2020 in the said institute due to non joining etc. of the candidates recommended by the BOPEE for admission through various Notifications.

In order to fill the vacant seats the candidates, who have appeared in the B.Ed. Kashmir entrance examination 2019 conducted by the Board, figure in the list as notified vide Notification No. 20-BOPEE of 2019 dated 10-04-2019 and are desirous of taking admission in the B.Ed. (Special Education) in CRC shall approach the BOPEE on 21-10-2019 for counselling. The candidates:-

- (i) who have scored at least 20.500 marks in OM and 16.500 marks in reserved category in the entrance test shall be eligible to participate in the said counselling and seats shall be filled up on the basis of inter se merit
- (ii) who have been recommended earlier but could not join the college for one or the other reason shall also be eligible;
- (iii) whose result was with-held due to non production of documents shall also be eligible.

Note:-

- Out of ten seats (08) are in OM and (02) are in reserved category (OSC=1 and RBA=1). However, in case candidates from the reserved categories are not available then these seats shall be treated as OM and filled up from amongst the OM candidates;
- (ii) Board may also maintain a wait list, if found desirable.
- (iii) The candidates who have already taken admission in B.Ed. Kashmir in IASE shall not be eligible and the settled admissions shall not be unsettled;
- (iv) The candidates selected for undergoing the course shall be directed to report to the College immediately for taking admission;
