Subject: - NEET UG – 2019 counselling/admissions- filling up of the additional sanctioned seats by the Ministry of Health and Family Welfare Government of India as a consequence of 10% quota of EWS.

# Notification No. 108-BOPEE of 2019 Dated 21-10-2019

Whereas, the Ministry of Health and Family Welfare (Department of Health and Family Welfare vide its communication dated 21-06-2019 conveyed its acceptance to the proposal of the BOG-MCI for filling up of MBBS Seats under EWS quota as per rules in forthcoming academic year 2019-2020 with a view to implementation of the reservation for EWS in admission to educational institutions under constitution amendment (103<sup>rd</sup> amendment) Act 2019 dated 12-01-2019. The Ministry of Health and Family Welfare vide communication dated 21-06-2019 provided the details of the colleges indicating permitted MBBS seats which in respect of J&K State are as under :-

\*One seat in GMC, Jammu has been reserved for implementation of the judgement dated 27-09-2019 and 05-10-2019of the Division Bench of the Hon'ble High Court in the LPA titled BOPEE Vs Vasundra Sharma LPA No. 203/2019 cw LPA No. 204/2019.

Whereas, Ministry of Health and Family Welfare further vide Communication dated 19-7-2019 conveyed approval to increase of seats in BDS courses in the two colleges of Jammu & Kashmir as under:-

Whereas, these (additional increased seats approved) seats could not be filled up during the first and subsequent rounds of counselling conducted by the Board based on which admissions to various Medical/Dental Colleges were made vide various Notifications as there was no provision of such a quota in J&K Reservation Act 2004 and the rules issued thereunder vide SRO 294 of 2005 dated 21-10-2005; and

Whereas, amendments in the reservation Act of 2004 have been carried out vide Reorganization Act of 2019 as enacted by the Parliament, which will have effect from 31<sup>st</sup> October, 2019. Besides, a provision for reservation for economically Weaker Sections has also been provided vide SRO 518 of 2019 dated 02-09-2019 in the reservation rules of 2005, which SRO shall be operative from 1<sup>st</sup> November, 2019 and vide the said SRO, the Government has also notified the procedures for issuance of certificates to the EWS by the prescribed Competent Authorities; and

Whereas, with a view to filling up of the additional seats, the Government filed two application Nos M.A. No. 1662 and 1933 in writ petition (c) No. 76 of 2015 titled Ashish Ranjan & Ors. Vs Union of India & Ors. before the Hon'ble Supreme Court for grant of extension in time in filling up of the seats and the Hon'ble Supreme Court vide its orders dated 02-09-2019 and 16-09-2019 has been pleased to extend the counselling and admissions in MBBS/BDS upto 30-11-2019; and

Whereas, the Board of Professional Entrance Examinations vide Notice No. 90-BOPEE of 2019 dated 11-09-2019 has also advised the candidates willing to compete against the quota as may be permissible for EWS out of the increase in intake for the above colleges to have their certificates prepared in accordance with the law so that the additional unfilled seats are filled up in the month of November, 2019; and

Whereas, Board has decided to fill up additional seats accordingly and in this regard it is hereby notified as under:-

- 1. The tentative Operative Seat Matrix for the additional seats for three Medical Colleges and two Dental Colleges as mentioned above is annexed as Annexure "A" to this notification.
- 2. The candidates who shall be in possession of valid EWS certificate issued by the Competent Authority as prescribed by law in pursuance of SRO 518 dated 02-09-2019 shall have to produce the same in original along with self-attested copy of the same in the BOPEE office at Jammu/Srinagar up to 12<sup>th</sup> of November, 2019. The certificates issued should bear a reference of SRO 518 of 2019 dated 02-09-2019. The certificates can be deposited only after first of November, 2019 in the Board Office Jammu/Srinagar. Incomplete certificates or the certificates issues without reference of SRO 518 shall not be entertained.
- 3. The Board shall conduct the counselling for filling up of the available seats under EWS and those under reserved categories as a consequence of the increased capacity of the above colleges and such seats as may become available as a consequence of allotment/upgradation, if any, in the Board office at Jammu/Srinagar simultaneously on 14-11-2019 and 16-11-2019.
- 4. The other unfilled seats as a consequence of above including those if any in ASCOMS/IDS shall also be filled during the said process of counselling. The candidates belonging to EWS who have not registered earlier or otherwise but are in possession of valid EWS certificates shall be given an opportunity to register themselves to be eligible for participating in the counselling subject to fulfillment of other conditions of eligibility as notified from time to time.
- 5. The candidates willing to participate in the counselling for consideration for allotment of seat if any in ASCOMS/IDS shall have to take a conscious decision and satisfy the Board about their ability to pay the fee to the colleges and in case of non-joining by the candidates after admission, Board reserves the right to initiate action against such candidates as the seats cannot be allowed to go waste merely because the candidates have not joined the college/course allotted to them.

- 6. The seats shall be allotted to the candidates on the basis of merit cum preference on their turn and with a view to complete the process expeditiously a letter of allotment/upgradation as the case may be shall be given to the candidates on spot so that they do not wait for the formal Notification and report to the colleges/courses allotted/upgraded immediately.
- 7. The candidates from EWS and other reserved category candidates willing to participate in the counselling for allotment/upgradation of MBBS/BDS seats shall be required to register their names in the Board Office, Jammu/Srinagar w.e.f. 23-10-2019 to 31-10-2019 from 10.00 a.m. to 04.00 p.m. on working days, only provisionally, with a view to enable the Board to determine the tentative number of candidates who will be allowed to participate in the counselling on the scheduled dates. The candidates shall have to fill up a bio data form also, which will be provided in the Board Office. However, EWS candidates shall have to produce the certificates issued by the Competent Authorities w.e.f. 01-11-2019 to 12-11-2019, without which they shall not be allowed to participate in the counselling.

## Following shall be eligible:-

- (a) All eligible candidates under EWS who have obtained certificates under SRO 518 of 2019 dated 02-09-2019. The counselling for EWS seats shall stop at a point where no seat is available.
- (b) EWS seats shall be filled up in the three Government Medical Colleges viz GMC, Srinagar, GMC, Jammu, SKIMS, GDC, Srinagar and GDC, Jammu where the intake capacity has been increased.
- (c) The distribution of the EWS seats shall be between the males and females as otherwise applicable under rules.
- (d) The EWS merit shall start after the cut off merit of the OM candidates allotted seats earlier.
- (e) Additional seats in the reserved categories shall be filled up as a consequence of increase of intake by allotment/upgradation of eligible category candidates.
- Candidates allotted MBBS seats in ASCOMS/IDS and now in possession of EWS certificate (f) shall also be eligible to compete against the EWS quota seats in three Government Medical Colleges.
- (g) Resultant seat(s), if any, in ASCOMS/IDS shall also be filled up through common counselling on the basis of merit cum preference from amongst the eligible and willing candidates.
- (h) Any seat remaining unfilled as a consequence of above in Government/Private Dental Colleges shall also be filled up through common counselling.

#### Following shall not be eligible:-

- (a) Rule 17 will not apply in the counselling process.
- (b) No change of college shall be permitted in respect of candidates, who have been allotted seats in OM in the Government Medical Colleges. The candidates allotted seats in Government/Private dental colleges in OM and now are in possession of EWS certificates shall be eligible for upgradation and to compete for EWS for MBBS seats in the three Medical Colleges. The resultant seats in BDS in OM/reserved categories in the dental colleges shall be filled up by allotment/upgradation from the respective categories only

## NOTE:-

1. Admissions so made under EWS shall be provisional and subject to the income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the selection will be terminated forthwith without

assigning any further reasons and without prejudice to such further action as may be necessary under the provisions of the law as applicable in the State.

- 2. In order to ensure that the admission process is completed in a time bound manner and within the cut of date as extended by the Hon'ble Supreme Court, the candidates shall be required to join the college at a short notice and as per the date as may be notified by the Board failing which the candidates shall have no claim for seeking admission and subject to the availability of the time. The unfilled seats due to non-joining etc. shall be filled up by the Board on a date as may be notified by it.
- 3. The candidates shall have to report in the BOPEE Office at 9.30 a.m. on the above given counselling dates for registration, attendance and subsequent counselling. No proxy shall be permitted and the seats shall be allotted on merit cum preference and any candidate missing the counselling on his/her turn will be considered only against the seats available subject to his/her eligibility. Consequential seats if any shall also be filled up during the process of counselling and the seat matrix shall be updated on minute to minute basis and reflected on the monitors available in the BOPEE Office, Jammu/Srinagar.
- 4. For facilitation of the candidates, the cut off score for already admissions made in different colleges/courses and categories is given in annexure A below seat matrix. For any query the candidates can contact on the following numbers:-
