With a view to filling up these seats, fresh Applications are invited from the eligible candidates who are desirous of seeking admission in **PG Diploma in Rehabilitation Psychology (PGDRP)- 2019** in CRC, Srinagar can submit their Applications from 14th Nov.2019 to 21st Nov.2019 (4 PM) during working days at BOPEE Office, Srinagar/ Jammu.

Those candidates who want to seek admission in above course are required to fill and submit Application Form alongwith the documents/ certificates. The prescribed format of Application Form is available on BOPEE website and also at its Office Jammu and Srinagar.

The candidates shall have to deposit fee of Rs.2000 (Rupees two thousand only) through POS Machines installed at BOPEE Office Srinagar / Jammu through National Credit Card / Debit Card / ATM Card or can directly deposit in BOPEE Account No. in favour of FA/CAO, J&K BOPEE . The A/c No.will be provided to the candidates in the BOPEE Office, Srinagar/ Jammu.

Further, the candidates who were earlier provisionally selected vide Notification No.111-BOPEE of 2019 dated 24.10.2019, but could not complete the admission process due to one or the other reason shall also be required to apply afresh on prescribed Application Form. However. Such candidates shall not required to deposit documents/ certificates/fee



again. However, the unfilled category seats if any shall be filled up from open merit , in case no category candidates are available.
