**Dated: -16-11-2019**

In pursuance of letter No. BOPEE/Exam- MD/AYUSH/2019 dated 21-10-2019, vide which admissions in MD/MS Ayurveda Course in JIAR were recommended and after the last date of joining viz 31-10-2019 (04:00 p.m), the College has reported a shortfall of 7 seats mentioned below. The Ministry of Ayush has extended the last date of admission for PG Courses in Ayush upto 31-11-2019 vide letter dated 15-11-2019. Therefore, the Board has decided to conduct physical round of counselling for filling up of 07 unfilled seats provisionally on 23-11-2019 in the Board Office, Srinagar/Jammu simultaneously. The following are eligible:-

1. The minimum cut off AIAPGET -2019 score is (40<sup>th</sup> percentile) in OM and (30<sup>th</sup> percentile) in reserved category. However, in respect of the candidate with bench mark disabilities specified under right of person with disability Act 2016, the minimum marks shall be at (35<sup>th</sup> percentile for General Category) and 30<sup>th</sup> percentile for unreserved category.
2. Reserved category candidates shall be considered only after the OM candidates are not available as there is no reservation in the said college.
3. All eligible candidates upto the said cut off score shall be eligible to participate in the counselling on 23-11-2019.
4. The candidates shall report in the BOPEE Office Srinagar/Jammu on 23-11-2019 at 9.30 a.m. for registration/attendance etc.
5. Those candidates who have not registered earlier in the BOPEE office Jammu/Srinagar for being placed in the merit list shall also be eligible for registration.
6. First timers shall have to deposit a fee of Rs.2000/- before they are allowed to participate in the counselling.
7. Other terms and conditions shall remain the same as notified vide Notification No.83-BOPEE of 2019 dated 17-08-2019.
