Notification No.003-BOPEE of 2020 Dated: 10-03-2020

Online Applications, duly affixed with latest coloured photograph, thumb impression and signature are invited from residents of the Union Territories of J&K and Ladakh, who are eligible and desirous of appearing in the Common Entrance Test (CET) (Engineering)-2020 for admission to Bachelor of Engineering & Technology Courses for the academic session 2020. The selection of the candidates shall be governed by the J&K Board of Professional Entrance Examination Act, 2002 and the Rules and Regulations there under; JK Reservation Act, 2004 as amended vide J&K Reorganization Act, 2019, and subject to further amendments, if any, by the competent authority, from time to time and the guidelines/information as contained in the Electronic Information Brochure-2020. These Rules, Regulations and e-Brochure are available on the official website(s) of the BOPEE www.jkbopee.gov.in/ www.jakbopee.org.

- 6. The syllabus for the examination/test is available in the e-brochure.

- 8. Date of Entrance Test: 26th April, 2020.
- 9. The candidates, in their own interest, are advised to go through the Information Brochure before filling up of Online Application Forms. The Board shall not be responsible for any act of omission or commission in filling up of the Online Application Form by the candidate. It shall be presumed that the candidate has gone through the information contained in the e-Information Brochure and has agreed to follow the conditions contained therein. No candidate can claim any alteration in conditions which have been incorporated in the e-Information Brochure and notified in advance.

- 11. The examination may be conducted Offline by the Board.



## **Online Application forms:**

Application Forms have to be **submitted online only** through the BOPEE websites <a href="www.ikbopee.gov.in">www.ikbopee.gov.in</a> (through URL's/ Links provided for this purpose) w.e.f. **12**<sup>th</sup> March to **31**<sup>st</sup> March, **2020**. The payment of **Rs. 1200/-** only (Rupees one thousand and two hundred only) as fee is to be made also online through the integrated Bill Desk Payment Gateway which can be used to make payment with any National Credit Card/Debit Card/Net Banking. The procedure for filling Application Form and eligibility etc. of the candidates has been given in detail in the **e-Brochure**. The applicants must necessarily, in their own interest, go through this e-Brochure before attempting to fill up the online Application Form.

The applicants are advised to fill the online Application Forms on their own or through a responsible person. The applicants can also avail of services at 'Common Service Centres' of J&K UT for filling up online Application Forms at nominal charge. They can also avail of the services at any National Informatics Centre located at the office of the Deputy Commissioner of the concerned District or at BOPEE office, Jammu/Srinagar or BOPEE office Jammu/Srinagar between 10:00 a.m. to 04:00 p.m.

# **Submission of Online Application Forms:**

The interested candidates have to upload the following scanned original / self attested certificates in PDF format with size from 100-200 KB along with the Application Form:-

- (i) Valid Residence Proof certificate of J&K or Ladakh as the case may be.
- (ii) Qualifying marks (12<sup>th</sup> class) certificate; ( where result is declared)
- (iii) Date of Birth Certificate(Matriculation issued by the Board); and
- (iv) Reserved category certificate, if any, (including Sports Certificate/ TFW certificate) on the prescribed proforma. (Duly renewed where ever applicable)

However, it is for the information of all concerned that afore-titled documents as required for submission of application form shall be considered provisional and subject to change(s) vide any order as may be issued by the Government subsequently.

#### Note:-

- 1. The candidates can change/ modify their online Application Form at any time before it is "submitted" online. However, for any subsequent modifications, if required, the candidates should approach the BOPEE office Srinagar/ Jammu. They are advised, in their own interest, not to share their 'login' details with any other person, lest he/she may get an opportunity to change important details in the Application Form. They can check the status of their Application Form on the official website(s) of the BOPEE. If any form is not confirmed for want of required information, the candidate concerned must report in the BOPEE office Srinagar or Jammu by or before 01st April, 2020 failing which his/her Application Form shall be rejected.
- For online, candidates shall also have to upload their photograph, signature and thumb
  impression images in JPEG format and size within the range of 10-50 KB as given in the
  instructions in the e-Information Brochure uploaded on the BOPEE website(s).

- 3. The candidates must, after filling up all the required entries, ensure that their online payment has been successfully made and all the requisite documents have been uploaded in specified format/size. Mere downloading of the Application Form does not mean that the candidate has submitted his/her Application Form successfully. Candidate should ensure that he/she keeps checking the status of his/her online application forms until it is scrutinized by the Board and approved/accepted.
- The candidates should enter valid e-mail address/mobile number on the application form, which shall be used by the Board in sending messages/mails to the candidates, wherever required;
- 5. For any help / assistance candidates may call "Help Desk" numbers during office hours of the working days.

## Eligibility

- 1. The Applicant must:
  - a. be a resident of J&K or Ladakh as the case may be.
  - b. have passed 10+2 or equivalent examination from a recognized statutory Board with Physics, Chemistry and Mathematics as compulsory subjects and with at least 50% marks for Open Merit Category candidates including the Children of Defence Personnel, Children of Para Military Force, Children of State Police Personnel and candidates possessing outstanding proficiency in sports and 40% marks for candidates belonging to SC/ST and Other Socially and Educationally Backward classes;
  - c. be at least 17 years old on 31st December of the relevant year (2020);
  - d. valid Category Certificate, if applicable
- 2. The candidates appearing/who have appeared in the 12<sup>th</sup> Class examination (Annual Session 2020) can also appear in the BOPEE test provisionally. However, they shall be required to produce the marks card of the said examination in support of having qualified the examination at the time of declaration of the result/counselling as may be notified by the Board.

## Syllabus etc:

The syllabus, the tentative number of seats, Reservation Policy etc. for the examination are given in the e-Brochure. The examination shall be conducted in one sitting of three hours duration and the paper shall contain 180 questions comprising different sections.

#### Note:-

The eligibility is bare minimum/provisional and shall be subject to such changes/bench marks as may be fixed by the concerned University. The Board shall on receipt of any such communication from the concerned authority/University notify the same, which shall govern the eligibility criteria.

#### Instructions:

- a) No under process certificate will be accepted;
- b) The information provided by the candidates in the online Application Form cannot be verified from the original documents by the BOPEE officials before admission of candidates. The information on the Application Form downloaded page or on the Admit Card of candidate shall in no case be construed as an acceptance of such information/category certificate by the BOPEE. Therefore, if at any stage, it is found that a candidate has provided false or incorrect information in respect of any eligibility condition(s), his/her candidature will be cancelled without any further notice;

## Warning:

- (a) The candidates are warned not to resort to any unfair / fraudulent means or act of impersonation at the time of Entrance Test or upload any objectionable material including a photo of any object, other than his/her own photograph while submitting the online form. In case, a candidate is found taking recourse to such acts, criminal prosecution shall be launched against him/her and his/her abettors. He /she shall be permanently debarred from appearing in the entrance Test in future.
- (b) Any candidate uploading image of an object other than his/her own photograph shall be disqualified from appearing in the Examination(s). Besides action as warranted under law shall also be taken against such candidate.

# Original Documents required to be submitted in the Institution at the time of Admission:-

- a) Marks certificate of the qualifying examinations (12<sup>th</sup> class marks certificate);
- b) Date of birth (Matriculation / Secondary School Certificate) from the Board of School Education;
- c) Residence Proof Certificate of UT of J&K or Ladakh as the case may be.
- d) Category Certificate, if any.
- e) Any other document as may be required by the Institution.

#### Note:-

- I. The sports category candidates have to indicate their sports category on the Application Form. They are also required to submit their Sports certificate(s) in the office of the Secretary, J&K Sports Council Jammu / Srinagar for determining their sports points which will be afterwards officially forwarded by the Council to the BOPEE. The BOPEE, however, shall not be responsible for non-inclusion of any candidate in the list forwarded by the Sports Council or for their delay in submission of sports points to the BOPEE.
- II. The candidates having more than one reserved category certificate can get benefit of only one category indicated and uploaded along with the Application Form, which in no case shall be changed afterwards. The candidate, whose category certificate has not been found valid, will be considered in open merit, if otherwise found eligible without any further notice.
- III. Candidates who select single choice/preference shall be considered for that course/college only.

#### Roll No Slip/Admit Card:

The Notification for downloading of online/electronic Admit Card will be issued separately. The candidates, who fail to download their admit card, must report in the office of the BOPEE Srinagar/Jammu immediately. The electronic admit card will indicate time, Venue and schedule of the Entrance Test. The electronic Admit Card shall have the space for photograph of the candidate. The candidate has to affix his/her photograph which should then be attested by a Gazetted officer. A candidate will in no case be allowed to appear in the Entrance Test without attested photograph on the Admit Card. The candidates are advised to remain in touch with the official Website(s) of BOPEE for updates for Centre notification and for other important information relating to Common Entrance Test (Engineering) 2020. The candidates will receive SMS and / or e-mails for updates at various stage during the entire process of filling up of the online application form till selection of candidates, if applicable.



## **Venue for Conduct of Examination:**

The Examination shall be conducted at Jammu / Srinagar simultaneously.

Issuance of Admit Cards and Date of Test:

Information with regard to availability of Online Admit Cards, Venue and Time of the Common Entrance Test will be issued separately in due course of time. The Entrance Test will be held on 26<sup>th</sup> April (Sunday), 2020.

#### NOTE-1:-

The online submitted form is purely provisional and is liable to be cancelled at any stage subject to the final verification of the documents and even at any stage, where such a document is proved to be fake/false.

## NOTE-2:-

Impersonation by any candidate by uploading any other object etc. other than his/her photograph shall lead him/her to disqualification, besides liable to be prosecuted under law.

#### NOTE-3:-

There will be a single paper comprising of 180 questions in Physics, Chemistry and Mathematics (Each subject will be of 60 Marks/questions) with 0.25 negative marking for each wrong answer. The time duration will be 3 hours. Syllabus for the test is given in e-Brochure.

NOTE 4:-

The entrance test has been re-scheduled and shall now be held on **26**<sup>th</sup> **of April, 2020** instead of 19<sup>th</sup> of April, 2020.
