Whereas, pursuant to the Notification No. 007-BOPEE Dated 10-04-2020, Board notified the Provisional Merit List of (PML) of Candidates who have qualified NEET PG 2020 both on office website and print media in leading news papers invited objections/representations, if any, against the position assigned to them (PML) up to 14-04-2020 (02 p.m.) and against this the Board has received few representations from candidates and responded them back individually by return e-mail(s).

Whereas, representations have been received from few competing candidates against PML notified vide Notification No: 007-BOPEE of 2020 dated 10-04-2020 stating there under that some candidates are either pursuing PG or are have left the courses midway/cutoff date prescribed by the Board.

Whereas the Board examined these individual representations and considered and noted that the following candidates have been found to have applied during online registration, who are either already pursuing PG/PG Diploma or have left the course midway/after cutoff date and are, therefore, ineligible to compete again in the NEET process 2020 notwithstanding having appeared in the examination and qualified the same and are not eligible for consideration for admission during session 2020 in terms of SRO 48 of 2018 dated 30-01-2018:
