**Subject: - Filling up of MD/MS Management Seats of Hindu Minority (HM) and Non-Resident Indians (NRI) Quota of ASCOMS, Jammu through Joint Counselling by J&K BOPEE.**

All those NEET – PG 2020 eligible candidates, who figure in Provisional Merit List (PML) of MD/MS/PG Diploma and are interested in the MD/MS seats of ASCOMS under Hindu Minority and NRI management quota seats are advised to deposit their documents on the prescribed proforma along with all relevant/required documents in BOPEE office Srinagar/Jammu **w.e.f. from 3<sup>rd</sup> May to 10<sup>th</sup> May, 2020**, the details of which is given below:

**Total Management Seats of ASCOMS = 23**

- (i) Open Merit (OM)\* = 06 (01= Anatomy, 01= Pathology, 01= Pharmacology, 01= Physiology, 01= Radio Diagnosis, 01=Biochemistry)
- (ii) Hindu Minority (HM)\*\* = 12 ( 01=Anaesthesiology; 02= ENT, ; 01 = Medicine; 01 = Microbiology, 01 = Obs. & Gyne., 01= Ophthalmology , 01 = Pathology, 01= Pharmacology, 01= Psychiatry, 01 = Surgery, 01=Biochemistry)
- (iii) Non-Resident Indians (NRI)\*\*\* = 05 (01 = Anaesthesiology; 01 =Medicine, 01= Obs. & Gyne. 01= Psychiatry, 01= Surgery)

(\* 06 OM seats under management quota shall be filled up on the basis of merit cum preference irrespective of religion/category, etc.).

(\*\* 12 Hindu Minority (HM) seats under management quota shall be filled up from the candidates belonging to Hindu Religion only with the condition that they shall produce a latest relevant document/certificate issued by the concerned competent authority).

(\*\*\* 05 NRI seats shall be filled up on the basis of merit cum preferences provided the necessary NRI documents are complete in all respects).

Only such candidates shall be considered under management/NRI/Hindu minority quota who are:

- (i) Resident of J&K / Ladakh;
- (ii) have applied under NEET-PG 2020 and have qualified; and
- (iii) have been found eligible to participate/compete against the J&K seats;

The eligibility criteria for competing under NRI quota seats shall be as under:-

(a) Where applicant himself/herself is NRI and family originally belongs to J&K /Ladakh **(Category 1);**

(b) Children/Ward of NRI who originally belong to UT of Jammu and Kashmir/Ladakh **(Category 2);**

(c) Any other condition as notified by the Government of India/UT Government of J&K/Ladakh or any direction given by the Hon'ble Supreme Court to be eligible to compete for such seats.

**Documents Required for NRI Category 1 and Category 2 candidates:**

- (ii) NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;

- (v) Copy of Income Tax Return filed in India, if any;
- (vi) PAN Card No., if any; and
- (vii) Resident Proof Certificate of the candidate belonging to J&K / Ladakh.
- (viii) Any other document as may be required by the Board to its satisfaction.

- (x) Copy of Income Tax Return filed, if any;
- (xi) Resident Proof Certificate of the candidate belonging to J&K / Ladakh.
