In continuation to Notification No. 009-BOPEE of 2020 dated 03-05-2020 read with Notification No. 011-BOPEE of 2020 dated 14-05-2020 and Notification No. 012-BOPEE of 2020 dated 19-05-2020, the Board has now decided to conduct second round of counselling (upgradation/allotment) round through physical counseling w.e.f. 28-05-2020 to 03-06-2020 through video conference. Accordingly, the schedule of counselling is hereby notified as under:-

Note:-

1. The registration for filling up of the preference forms by the candidates for participation in the physical counselling in the BOPEE Office, Srinagar/Jammu will start from 9.00 a.m. to 10.30 a.m. on each day of counselling and the counselling will start from 10.45 a.m.
2. Any candidate(s) who is not in a position to report physically in the Board Offices are advised to email their preference forms with ID proof one day before the date of his/her actual date of counselling i.e. the rank 1 to 200 (who cannot participate physically) shall e-mail their preferences form with ID proof, EWS category certificate, if any, on 27-05-2020. **The preference form is attached with this Notice. The e-mail ID for this purpose is pgbopee@gmail.com . Further, the candidates are advised to keep their mobile on during the day of his/her counselling.**
3. The filling up of the unfilled seats/seats under Hindu Minority Quota/NRI in ASCOMS shall be filled up during the process of counselling from amongst the eligible candidates strictly as per merit cum preference.
4. To claim the seat under EWS category, the candidate(s) who is in possession of valid EWS certificates issued by the competent authority under SRO 518 of 2019 dated 02-09-2019 are advised to bring the original certificate along with duly self-attested copy of the certificate on the date of his/her counselling.



In furtherance to the terms and conditions/instructions notified vide Notifications No. 011-BOPEE of 2020 dated 14-05-2020 and Notification No. 012-BOPEE of 2020 dated 19-05-2020, the following instructions are added:-

- a) The Board shall fill up the shortfall seats and the seats which have remained unfilled during the first round of online counselling as per the procedure adopted by the Board during the year 2019 i.e. each category seat shall be filled up from amongst the respective category candidates as per their merit-cum-preference as provided also in Information Brochure 2020, which is supported by the Hon'ble High Court Judgment titled Akhil Gupta Vs State & Ors.
- b) The EWS seats shall be allotted only to such candidates, who possess a valid EWS certificate issued by the competent authority with reference of SRO 518 of 2019 dated 02-09-2019;
- c) The candidates upgraded/allotted a seat during the second round of counselling shall be given an authority letter addressed to the Head of the allotted/upgraded college to enable the candidate to join the discipline/college immediately without waiting for issuance of final Notification, which shall be issued after conclusion of the counselling process i.e. 05-06-2020;
- d) The candidates who miss the counselling on the particular date of his/her turn shall be allowed to participate on the next day of counselling but he/she shall get the seat whatsoever available at that point of time and he/she shall have no claim on the seat, which otherwise he/she will have been allotted at his own time of counselling notwithstanding his merit-cum-preference;
- e) The candidate who has been allotted a seat during the first round of online counselling and has joined against the said allotted seat shall be eligible to participate in the second round of counselling and in case he/she may not get upgraded to the seat/college of his/her choice during the counselling shall either retain his/her seat allotted during first round of counselling or shall be eligible to submit his/her resignation to the concerned college/institute from **04-06-2020** till the last date of joining of the candidates, who are upgraded/allotted seats during second round of counselling.
- f) During the counselling process, the participating candidates are advised to maintain the guidelines issued by the Government from time to time in order to contain spread of COVID 19.
- g) The candidates are advised not to park any vehicle around the Board Office Srinagar as it creates problems for the local resident and also the Board management. The candidates are accordingly advised to park the vehicles at the parking places outside the BOPEE lane on their own risk and responsibility without creating any traffic jam.

The above shall be subject to outcome of writ petitions, pending, if any, before any competent court of law.

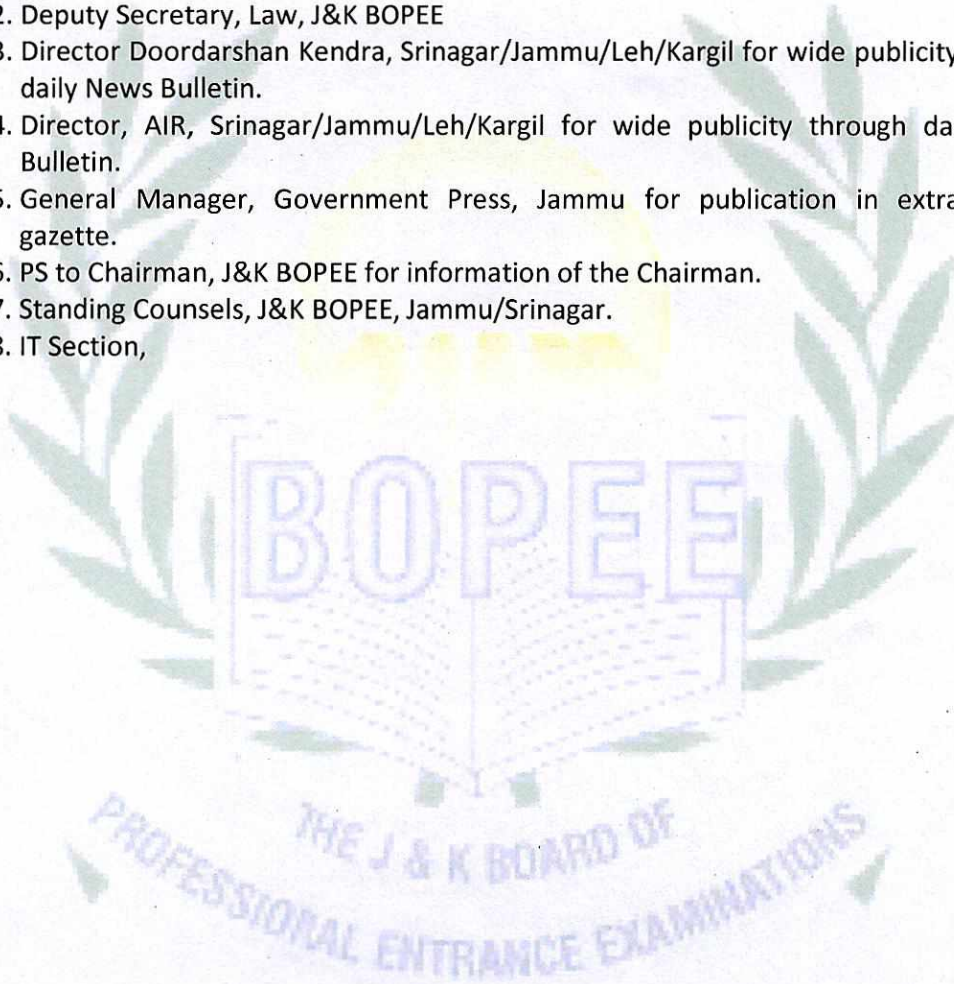
