Notification No. 17-BOPEE of 2020 Dated 15-07-2020

Consequent upon completion of second round of upgradation/allotment round of counselling for MD/MS/PG Diploma held w.e.f. 28-05-2020 to 03-06-2020, the mopping up round for unfilled seats due to non-joining and resignation etc. as per seat matrix already uploaded on the official website of the Board shall be held in the Board Office simultaneously at Jammu and Srinagar as per the following schedule given here in below:-

The eligible and willing candidates have to report in the BOPEE office for registration and fulfillment of all formalities, as compulsorily required and notified from time to time, before they are allowed to participate in the counselling process from **8:30 A.M upto 10:00 A.M**

Any candidate(s) who is not in a position to report physically in the Board office Jammu/Srinagar during mop up round is/are advised to e-mail their preference form with ID proof, receipt of counselling fee for newly registered candidate(s) only, at least day before the date of his/her actual date of counselling as specified above.

The preference form is attached to this notification as **Annexure A**. The e-mail ID for this purpose shall be pgbopee@gmail.com


Further, for online process, the candidate(s) are advised to keep their mobile phones on mode during the day of his/her counselling. The allotment of seats shall be on day to day basis & for tracking of seat(s) records, the candidate(s) who will be participating through on line mode may also authorize a person of his/her close proximity to remain present at BOPEE office Jammu/Srinagar along with an **Authority letter** annexed as **Annexure B** to this notification.

It is further notified that the candidates may go through the Notification carefully and only the following candidates shall be eligible to participate in the mop up round of counselling and in case of non fulfillment of the conditions mentioned herein below such candidate(s) **are debarred / not allowed to participate in mop up round :-**

- 1 The candidates who have not been allotted any seat during the 1st / 2nd round of counselling shall be eligible to participate in the mopping-up round in terms of conditions contained in the Information Brochure.
- 2 The Board has also decided to allow such candidates to participate in the mopping-up round, who have been allotted a seat during 1st round of counselling and have joined the college but have not been upgraded during the 2nd round owing to less merit and those who have been allotted seat during the 2nd round of counselling and have joined the college/institution and wish to participate in the mopping-up round for purpose of upgradation. **However, any candidate upgraded during the 2nd round shall under no circumstances be eligible to participate in the mopping-up round.**
- 3 The candidates who will be allotted seats during the mopping-up round shall have to necessarily join the college/institution upto 27-07-2020 (4:00 p.m) and shall not be allowed to resign. However, such candidates, who do not join the college upto to the prescribed date or resign subsequently, will **attract penal provisions of SRO 48 of 2018 dated 30-01-2018 and shall be debarred for 3/2 years as laid down in the said SRO as also reiterated by the Board from time to time** . The candidates should, therefore, take a conscious decision about participation in the mopping-up round for allotment of a seat;
- 4 The candidates should go through all relevant Notifications/Notices along with the e-Brochure notified by the Board with particular reference to the mopping-up round of counselling;
- 5 If any reserved category seat(s) remain unfilled due to non-availability of eligible candidates, they shall be **converted into OM** after completion of counselling on 20-07-2020 immediately after conclusion of the counselling of reserved category candidates.
- 6 The category candidate, who may not get a seat in his/her category shall be eligible to participate in the counselling as an OM candidate as per his/her merit upto NEET Score 275 from **21-07-2020 to 23-07-2020**.
- 7 The candidates who **have already resigned against the seats allotted to them during first and second rounds of counselling shall not be eligible to participate in the mopping up round of counselling.**
- 8 The candidates, who have joined ASCOMS under HM/NRI/OM Quota and are desirous to participate in the mop up round against seats available in Government Institutions shall be eligible to participate in the mop up round. Further, ASCOMS

candidates under NRI category will also be eligible to participate in the mop up round subject to their eligibility.




