The Board vide Notice No. 043-BOPEE of 2020 dated 13-08-2020 and Notice No. 044-BOPEE of 2020 dated 13-08-2020 notified the list of candidates, who had deficiency of documents/certificates required for admission to Three Year Diploma Polytechnic and 10<sup>th</sup> Based Para Medical Courses (FMPHW and MMPHW), 2020, and were advised to remove such deficiencies by submitting the deficient documents/certificates through e-mail <a href="mailto:bopeehelpdesk@gmail.com">bopeehelpdesk@gmail.com</a> or by hand upto 21-08-2020.
