

Online Registration of qualified candidates of NEET UG - 2020.

Consequent upon the declaration of the NEET UG - 2020 result by National Testing Agency (NTA) on 16-10-2020 and with a view to update the category status and preparation of the Provisional UT Merit List (PML) of registered candidates, it is hereby notified that the candidates who have secured the minimum qualifying marks in NEET UG - 2020 shall be required to register themselves and upload the following documents online w.e.f. **07-11-2020 to 12-11-2020.**

- 1. NEET-UG score card.
- 2. 10+2 marks card.
- Domicile Certificate for candidate belonging to UT of J&K and ST Category certificate in respect of candidates belonging to the UT of Ladakh as a Domicile certificate or an undertaking by the candidate that he/she will produce the domicile at the time of counselling
- Category Certificate, wherever required.
- 5. Date of Birth Certificate (Matriculation).

The cut off score for different categories is as under:-

- a. Open Merit/JKPM (including child of Para Medical Forces)/CDP/Sports/EWS: 147
- b. SC/ST/RBA/ALC/OSC (for J&K/Ladakh):

113

The tentative NEET score list of candidates of J&K, who have appeared in the NEET-UG 2020 has already been notified vide Notification No. 042-BOPEE of 2020 dated 30-10-2020, which is available on the BOPEE website www.jkbopee.gov.in only. Mobile phones should not be used for registration purposes for uploading of documents, as software will not accept the same.

The e-Information Brochure for NEET UG-2020 Courses shall be notified by the BOPEE in due course of time. The candidates are advised to go through the e-Brochure before registration.

Declaration of PML (Tentative): 15-11-2020

Online filling up of preference forms (Tentative): - 18-11-2020 to 23-11-2020

NOTE 1:-

- 1. No under process certificate shall be entertained;
- The category certificates issued only up to the last date of registration shall be entertained. Any certificate issued after the registration date shall not be entertained by the Board;
- The candidate must fulfill all other criteria as laid down in the NEET-UG 2020 Information Brochure of NTA and Information Brochure of BOPEE in respect of NEET-UG, 2020 courses;
- Any candidate found ineligible at any point of time shall not be allowed to participate in the counseling process notwithstanding the registration/NEET qualifying score;
- S. The candidate should upload their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them;
- Candidates, in their own interest, are advised not to share e-mail password with other candidate/person;
- 7. Board shall not be responsible for any mistake committed by the candidates, while making registration;
- After completion of the registration process, Board shall notify the Provisional UT Merit List (PUTML) of all the candidates, which shall be used for online counseling by the candidates (filling up of the preferences) based on which allotment of seat shall be made;
- Any candidate, who falls within qualifying merit but does not register himself/herself or does not upload the documents or the documents uploaded are deficient shall not be considered for allotment of a seat;
- 10. The candidates, in their own interest, are advised to go through the e-Information Brochure available on the website of the BOPEE viz. www.Jkbopee.gov.in and go through the technical and other instructions before registering themselves;
- 11. Since the admission in the Professional Colleges is time bound, the candidates should not wait for last date of registration as it may even be detrimental to the interest of the candidates(s);
- 12. The candidates shall have to fill in following fields which are mandatory in nature and without which they cannot process further:-
 - Student Roll No.
 - ii. NEET Score.
 - iii. NEET Rank.
 - iv. Date of Birth.
 - v. Gender

- 13. The candidates, who intend to participate against NRI/HM Quota seats in ASCOMS, Jammu/IDS, Sehora shall also have to register themselves online and submit all such documents offline in the Board office up to the date as may be notified by the Board separately;
- 14. Candidates are advised to remain in touch with the BOPEE website www.jkbopee.gov.in and should not wait for publication of Notices/Notifications in the News Papers, which may get delayed for the reason beyond the control of the BOPEE.
