Conduct of Mop-up Round of Physical Counselling for upgradation/allotment seats in B.E./B.Tech. Engineering Courses, 2020 in Government/Private Engineering Colleges of UT of J&K /Ladakh

After the receipt of shortfall from various Disciplines of B.E/ B.Tech. (Engg.) courses in Government/Private Engineering Colleges of UT of J&K, the Board has decided to conduct Mop-up round of Physical Counselling for allotment /upgradation of seats tentatively w.e.f 27-11-2020 as per the schedule given below:-

The seats received as shortfall or remained unfilled after conclusion of second round of physical counselling shall be filled during this mop-up round under open merit category and not under any reserved category strictly in order of merit cum preferences basis.

PROCEDURE FOR MOP-UP ROUND FOR UPGRADATION/ALLOTMENT OF SEATS:

The following procedure shall be followed:

- Subject to the limits fixed by the Board due to COVID-19, the candidates as notified
 by 039-BOPEE of 2020 dated 21-10-2020 and qualifying for the upgradation/
 allotment of seats in the mop-up round as per laid down norms shall attend the
 counselling on the day /date and time mentioned hereinabove;
- The eligible and willing candidates have to report at the BOPEE offices Jammu / Srinagar for registration/attendance & fulfillment of all formalities, from 09:00 AM upto 10:30 AM on their day/date of counselling.
- 3. The candidate(s) participating in the physical round of counselling and getting allotted a seat, should in their own interest not leave the Board office as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling may become available during the process. He/ She can stake a claim on such a seat immediately once the seat is displayed in the seat matrix on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant and be added to the seat matrix. The Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as above.

- 4. Candidate who has opted for C.N.A/S.N.A or who could not attend counselling due to unavoidable circumstances or the candidates who have not joined the college on allotment of seat during the first/second rounds of physical counselling for one or other reasons are eligible to attend the Mop-up round of Physical Counselling for up-gradation / allotment of seats in B.E/B. Tech. (Engineering) courses.
- 5. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.

Note:

- i) All the candidates reporting at BOPEE offices Jammu/ Srinagar shall strictly adhere to COVID-19 Advisories issued by the UT Government of J&K from time to time.
- ii) Seat matrix shall be uploaded separately within due course of time before counselling.

The other terms and conditions shall remain the same as notified in the Information Brochure and Notifications/Notices issued in this regard from time to time.
