Subject: - Provisional Admission to PG Diploma in Rehabilitation Psychology in CRC-Course, 2020.

Reference: - (i) Notification No. 040-BOPEE of 2020 dated 26-10-2020.
(ii) Letter No.CRC-Sgr/acad/4000/27 dated 25-09-2020

Notification No. 053-BOPEE OF 2020 DATED 30-11-2020

Whereas, vide Notification No. 040-BOPEE of 2020 dated 26-10-2020 applications were invited for admission to PG Diploma & Rehabilitation Psychology, 2020 in Composite Regional Centre (CRC), Bemina, Srinagar with the qualification as mentioned in above referred to Notification.

1. Bachelor's Degree(Regular Mode) with General Psychology Courses in all the three years; or
2. Master's Degree in any Branch of Psychology either in Regular Mode or Distance Mode; or
3. Master's Degree in Counseling Psychology either in Regular or Distance Mode;
4. Have obtained a minimum of 55% marks in aggregate for OM category candidates, minimum 50% marks for SC/ST/OBC (renewed category) in aggregate is essential. Entry qualification shall be from a UGC recognized university.

Whereas, the above qualification was notified in pursuance of a communication received from Composite Regional Centre, on the subject; and

Whereas, upto the last date of receipt of application forms viz 05-11-2020, 26 applications were received by the Board physically, which have been scrutinized and following has been observed:-

- i) One candidate has been found ineligible not possessing the requisite percentage of marks as above and, therefore, her candidature is rejected:-

Lubina Bashir D/o Bashir Ahmad Bhat.

- ii) 25 candidates belonging to three categories viz those possessing Bachelor's degree with general Psychology Courses in all the three years; those possessing Bachelor's degree with general Psychology Courses in all the three years with Master's degree in any branch of Psychology and those possessing only Master's degree in Psychology in accordance with the above qualification, have been found eligible;

Whereas, the Board having considered the matter in totality accordingly devised the following criteria for making selections:-

- i) 90% weightage on pro-rata basis to the marks obtained in qualifying examination viz Bachelor's degree/Master's degree in Psychology as the case may be;


- ii) 10 additional points to the candidates possessing Master's degree in any branch of Psychology in addition to Bachelor's degree with general Psychology and;

Whereas, on the basis of inter-se merit of the eligible candidates with due regard to reservation rules, 20 candidates as per **Annexure-A** have been shortlisted for admission to PG Diploma & Rehabilitation Psychology, 2020 in Composite Regional Centre, Bemina, Srinagar and is notified accordingly. A waiting list of 5 candidates is annexed as **Annexure-B** to this Notification.

Now, therefore:-

- i) the candidates as per **Annexure-A** to this Notification are hereby provisionally selected for admission to PG Diploma & Rehabilitation Psychology, 2020, who shall report to the Composite Regional Centre, Bemina, Srinagar, Kashmir upto **10th December, 2020** along with all necessary documents for verification and further scrutiny by the said Centre who shall allow them to join only on production and verification of original requisite certificates including Domicile certificate of the candidate;
- ii) the candidates as per Annexure-B to this Notification have been placed in the waiting list, which shall be operated upon by the Composite Regional Centre, Bemina, Srinagar on **11th December, 2020** morning against the seats, if any, which shall remain vacant due to the non-joining of the candidates figuring in Annexure-A. The joining time in such cases shall be **upto 15th December, 2020**;
- iii) The CRC shall forward list of admitted candidates to the BOPEE along with shortfall, if any, on 16-12-2020 (02:00 p.m) through e-mail.


