- 2. The merit list of the candidates has been prepared on the basis of aggregate marks obtained in the qualifying examination i.e. in B.Sc. Nursing. In case of tie between candidates, same shall be resolved by taking into account the date of birth of candidate's i.e candidate older in age is preferred first as already mentioned in Notification No: 037-BOPEE of 2020 dated 10-10-2020.
- The intending candidates shall keep ready their domicile certificate, Work Experience,
  Registration certificate etc. issued by the competent authority along with all other
  original documents as required by the concerned Principals at the time of admission to
  their respective colleges after allotment of seats to them.
- 4. The candidates must remain in touch with the official website of the Board so as to be abreast of the final schedule of the counseling which shall be held physically at BOPEE office Jammu/Srinagar simultaneously and shall be notified separately after the deposition of objections/documents, if any, received from intending candidates mentioned in the Provisional Merit List to be uploaded on the official web site of the Board www.jkbopee.gov.in.


