#### Note:-

- It is compulsory for all the eligible candidates, who have been called for counselling
  as per the above schedule shall bring with them the copy of Application Form
  submitted by them at the time of applying for the above courses.
- 2. The candidates, whose Documents/Certificates like Domicile Certificate, 12<sup>th</sup> class qualification certificate and category certificate, if any, are deficient, can produce the same on the day/time of the counselling at BOPEE office Jammu/Srinagar, failing which they shall not be allowed to participate in the counselling process on their own risk and responsibility and their candidature shall be cancelled abinitio.
- 3. Candidates shall have to make the payment of Rs. 1000/- as counselling charges, through POS machines available in the BOPEE Office, Jammu/Srinagar on the

day/date of counselling .However, the candidates can deposit the counselling charges before the day/date of their counselling through POS machines at BOPEE office Srinagar/Jammu, so that the social distance is maintained during the counselling .The candidates are strictly advised to follow the SOP's and guidelines issued by the government with regard to COVID-19.

- 4. The Reservation Policy shall be applicable in respect of Government Institutions only under S.O. 127 of 2020 dated 20-04-2020.
