**Subject: - Modification to Notification No-063-BOPEE of 2020 dated 23-12-2020.**

Whereas, in pursuance of Notification No. 059-BOPEE of 2020 dated 07-12-2020, the J&K BOPEE received shortfall of one seat under STGB category form GMC-Baramulla on 12-12-2020; and

Whereas, the Board during conduct of 2<sup>nd</sup> round of physical counselling held from 19-12-2020 to 23-12-2020, filled up the said seat of STGB category vide Notification No. 063-BOPEE of 2020 dated 23-12-2020; and

Whereas, the last date for joining of the candidates was prescribed upto 28-12-2020 and the Principal, GMC-Baramulla intimated the Board that one candidate under STGB category has been admitted by the said College in excess of the sanctioned; and

Whereas, the Principal, GMC-Baramulla was telephonically informed that the said seat of STGB category has been filled as per shortfall conveyed by the College, accordingly no excess seat has been allotted by the Board under STGB category; and

Whereas, the Principal GMC-Baramulla, informed that the Board has considered the shortfall conveyed on 12-12-2020 when the final shortfall mailed on 13-12-2020 as nil; and

Whereas, vide Notification 059-BOPEE of 2020 dated 07-12-2020 the last date for submission of shortfall by the Colleges was prescribed as 14-12-2020 (05:00 P.M); and

Whereas, the Board during 2<sup>nd</sup> round of up-gradation of physical round of counselling upgraded the candidates against the said vacant seat which was shown as non-joined; and

Whereas, the Principal, GMC Baramulla vide Communication No. GMC/Bla/Acad/2332-2333 dated 28-12-2020 has conveyed that one candidate under STGB category has been admitted in excess of the intake capacity of the College and has requested the Board to withdraw the excess seat of STGB category to balance the intake.

Now keeping the approved intake capacity of the College and carrier of the candidate in view, it is hereby notified that the following partial modification is hereby made to the Notification No. 063-BOPEE of 2020 dated 23-12-2020 and the status of the following



two candidates shall remain same as mentioned in the Notification No. 059-BOPEE Of 2020 dated 07-12-2020, resulted in no shortfall against STGB category in GMC-Baramulla:-
