

In case of tie between candidates, same have been resolved by taking into account the date of birth of candidate's i.e. candidate older in age is preferred first.
3. **The candidates must remain in touch with the official website of the Board, so as to be abreast of the final schedule of counselling which shall be held physically at BOPEE office, Jammu/ Srinagar simultaneously and shall be notified separately after the deposition of objections/ documents, if any, received from intending candidates mentioned in the Annexure "A" to this notification available on the official website of the Board (www.jkbopee.gov.in)**
4. In case no objection(s) are received within the prescribed date and time by the Board, these provisional merit list shall be deemed to be treated as final.

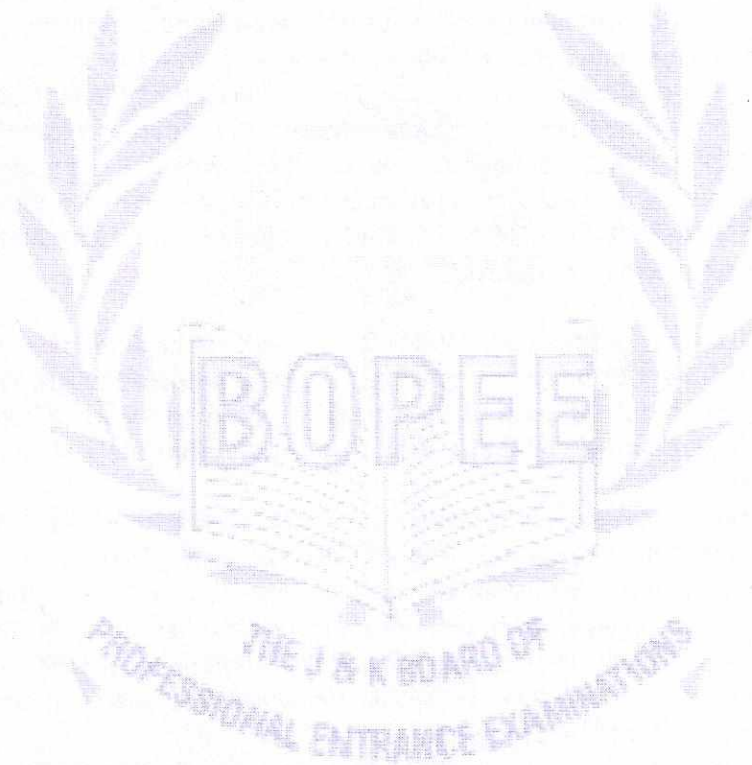
