
Consequent upon completion of first round of physical counselling of eligible candidates for admission to M.Sc. Nursing Courses-2020 in Government/ Private Medical Colleges of UT of J&K and subsequent receipt of shortfall by the Board from the said colleges/ Institutions, the second up-gradation / allotment round of physical counselling is hereby notified to be held on **31st of January-2021** at BOPEE Office, Srinagar/ Jammu simultaneously through video conferencing.

The candidates desirous of participating in the counselling process shall report in the BOPEE Office, Srinagar/ Jammu for Attendance/ Registration on the prescribed date (**31st of January-2021**) of counselling between **9.30 AM to 10.30 AM** for being eligible to participate in the counselling at their own turn/ rank.

1. The candidates who have been allotted the seat/college during first round of allotment counselling but failed to join against the said allotted seat(s) / college(s) shall not be eligible to participate in this round of up-gradation counselling.
2. The candidates who have joined the college on the basis of first round of counselling and wish to participate in the second round, of up-gradation counselling can do so, however, if the candidate gets upgraded shall loose the earlier allotted college and in case he/ she is not up-graded shall retain his/ her earlier seat. The candidates who participated in the first round of counselling but could not get a seat due to SNA/ or CNA shall also be eligible to participate in this round of counselling.
3. The candidates who are eligible and are desirous to participate in the up-gradation/allotment round shall be required to indicate the fresh preferences for the seats/colleges to be filled-up during the said round of counselling.
4. The seat left out by the OM candidate during the first round shall be allotted to OM candidate and those left by the category candidates shall be allotted to the available category candidates only during this round of counselling and in case no eligible candidate is available in the respective Reserved Category(s), the said seat(s) shall be converted to open merit and shall be allotted to the eligible open merit candidate under Rules.
5. The other terms and conditions shall remain the same as mentioned in the e-Information Brochure/ Notifications/ Notices issued by the Board from time to time.

6. The seat matrix shall be uploaded on official website of the Board in due course of time.
