Pursuant to Notification No. 037-BOPEE of 2020 dated 10.10.2020 read with Notification No.004-BOPEE of 2020 dated 09.01.2021 and Notification No.012-BOPEE of 2020 dated 22.01.2021 where under applications were invited for admission to M.Sc. Technology Courses-2020 at SKIMS, Soura, Srinagar from the eligible candidates of UT's of J&K/ Ladakh. The Board vide Notification No.004-BOPEE of 2020 notified the provisional merit list of the candidates who had applied for the said course and sought objections, if any, thereof. In furtherance, the Board vide Notification No.004-BOPEE of 2021 dated 04.01.2021 advised the candidates to submit representation(s) against his/ her position given in the annexure of the said notification and also advised such candidates who had deficiency of any required document as shown in the said list to clear the same by or before 16-01-2021 positively, otherwise their candidature shall be treated as cancelled on their own risk and responsibility.

The Board after completion of all formalities and keeping prescribed cut-off date in view, published the final list of eligible candidates vide Notification No.012-BOPEE of 2020 dated 22-01-2021. Accordingly, it is hereby notified for information of eligible candidates that the physical round of counselling for admission to M.Sc. Technology Courses -2020(at SKIMS, Srinagar) shall be held on 09.02.2021. **The candidates are hereby informed through the medium of this notification to report at BOPEE Office, Srinagar/ Jammu at 9.30 AM to 10.30 AM on 09-02-2021 for Attendance / Registration/ Allotment Counselling.**

The Board shall conduct the counselling of Reserved Category Seats including STL/STK/PwD in the first instance and in case any seat under any Reserved Category remains unfilled due to non-availability of eligible candidates, same shall be converted in to open merit and filled-up accordingly.

Note:

- The candidate bearing Rank 55 has been treated as open merit candidate due to the fact that his Reserved Category Certificate stands expired.
- The interested candidates are also advised to keep ID proof & all other documents with them for identification at the time of counselling.
- The seat matrix shall be uploaded on official website of the Board (www.jkbopee.gov.in) in due course of time.
- The other terms and conditions shall remain same as laid down in the notifications/notices issued in this regard from time to time.


