
Consequent upon completion of first round of physical counselling held from 05.01.2021 to 12.01.2021 for filling-up of seats which remained unfilled during first round of counselling, the Board has decided to conduct second round of physical counselling on **11th of Feb.2021** at BOPEE Office, Srinagar/ Jammu simultaneously.

The candidates desirous of participating in the counselling process are advised to report at BOPEE Office, Srinagar/ Jammu for attendance/ registration between **9.30 AM to 10.30 AM** on the prescribed date i.e. (11-02-2021) for being eligible to participate in the counselling at their own turn/ rank.

Note:

- 1, The candidates who have been allotted the seat/ college during first round of allotment counselling but failed to join against the said allotted seat(s) / college(s) shall not be eligible to participate in this round of counselling.**
- 2. The candidates who have joined the college on the basis of first round of counselling and wish to participate in the second round of up-gradation counselling can do so, however, if such candidate (s) may get upgraded he/ she shall loose the earlier allotted college and in case he/ she is not up-graded shall retain his/ her earlier seat . The candidates who participated in the first round of counselling but could not get a seat due to SNA or CNA or the candidates who remained absent during first round of counselling shall be eligible to participate in the second round of counselling.**
- 3. The candidates(s) eligible/ desirous to participate in this up-gradation/ allotment round shall be required to indicate the fresh preferences for the seats to be filled-up during this round of counselling.**
- 4. The other terms and conditions shall remain the same as mentioned in the e- Information Brochure/ Notification/ Notices issued by the Board from time to time.**
