In pursuance of Notification No.017-BOPEE of 2021 dated 04.02.2021, the physical round of counselling of eligible candidates held on 10.02.2021 for admission to 12<sup>th</sup> based Paramedical Courses in Medical Record Technician Course-2020 at SKIMS, Soura, Srinagar The candidates who participated in the said counselling and have been allotted seats as per their merit-cum-preferences are hereby provisionally selected for admission to the Medical Record Technician course-2020 in SKIMS, Soura, Srinagar as per Annexure "A" to this notification which is available on website of the Board [www.jkbopee.gov.in](http://www.jkbopee.gov.in) only for completion of admission process, the candidates are advised to report the Institution from 11-02-2021 to 18-02-2021(3.00 PM) alongwith the following documents:-

1. Date of Birth Certificate of 10<sup>th</sup> class
2. Marks Card of 10+2 class
3. Domicile Certificate
4. Category Certificate, if any
5. Any other Certificate/document required by the College Authorities.

It shall be sole responsibility of the Colleges/ Institutions to ensure proper check and verification of documents before the candidate is allowed for admission and in case of any discrepancy in the requisite documents, the same shall be reported to the Board for further course of action as warranted under rules.

The candidates provisionally selected shall have to join against their allotted seat(s) upto 18<sup>th</sup> Feb.2021 positively and in case any candidate fails to join his/ her allotted seats shall not be eligible to participate in subsequent rounds of counselling, if any, conducted by the Board under any circumstances.

In order to complete the admission process within the prescribed cut-off date (18-02-2021) the SKIMS shall keep its admission counters open even on holiday/ off day. However, the candidates should their own interest shall avoid waiting for the last day to complete admission formalities as such delay has the potential of causing hardships to the candidates only.


