Consequent upon receipt of shortfall from various Colleges/ Institutions, the Board has decided to conduct second round of physical up-gradation/ allotment counselling of eligible candidates for admission to GNM and GNM (Lateral Entry) courses-2020 on 15<sup>th</sup> & 16<sup>th</sup> of Feb.2021. The interested candidates are advised to report at BOPEE Office, Srinagar/ Jammu between 9.30 AM to 10.30 AM for Attendance/ Registration. The schedule of counselling, shall be as under:-

Date	Name of the Course	Rank
15.02.2021	GNM (Lateral Entry) candidates only	All eligible candidates.
16.02.2021	GNM candidates	All eligible candidates.

The Board shall first conduct the counselling of all Reserved Category candidates and the seats, if any, remain unfilled due to non-availability of eligible candidates shall be converted into open merit and allotted to the candidates under such category on merit basis. However, the category candidates, if any, who wish to participate in the counselling under open merit category, shall have to wait at his / her respective place of counselling till he/ she is called again under open merit.

The candidates who have failed to join against the allotted seats during first round of counselling shall not be eligible to participate in this round of counselling.

The candidates who failed to attend the counselling due to one or the other reason shall be eligible to participate in this round of counselling.

The candidates in whose case choice was not available or seat was not available (CNA/SNA) during first round of counselling are also eligible to participate in this round of counselling.

Note:-

- All eligible candidates who are interested to participate in the counselling process scheduled to be held on 15.02.2021 & 16.02.2021 are advised to bring the receipt of admission fee deposited by them at the respective College/ Institution allotted to them by the Board during first round of physical counselling.
- The seat matrix shall be uploaded separately in due course of time.
- The other terms and conditions shall remain the same as notified vide e-Information Brochure, Notifications and Notices issued by the Board from time to time.
