## The following shall be eligible to participate in the mopup round of counselling:-

- 1. The candidates who have been allotted seats during second round of counselling and have joined in their respective allotted colleges/courses.
- 2. The candidates who could not participate in the first and second round of up-gradation/ allotment counselling for one or the other reason.

  Further,
- a) The reserved category seats, if any, which shall remains unfilled after conclusion of counselling of the candidates, shall be converted into open merit and accordingly allotted to the eligible candidates in order of merit and choice.
- b) The reserved category candidate(s) if any, not upgraded due to non availability of his/ her choice of seat/ Institution under reserved category, can participate in further counselling as an open merit candidate on the same date as per his merit.

## The following shall not be eligible to participate in the mop-up round of counselling:-

1. The candidates, who have been allotted seat(s) in the second round of counselling but failed to join the same within the prescribed time limit fixed by the Board.

The other terms and conditions shall remain the same as notified in the e.Information Brochure/ Notifications/ Notices issued by the Board from time to time on the subject.
