
The Board vide Notification No. 033-BOPEE of 2021 dated 06-03-2021 read with Notice No.037-BOPEE of 2021 dated 30-03-2021 & Notice No. 038-BOPEE of 2021 dated 05-04-2021, invited online applications from the eligible candidates of UT's of J&K/ Ladakh for admission to **B.Ed. in Institute of Advance Studies in Education (formally Govt. College of Education) M.A Road, Srinagar & B.Ed. (Special Education) in Composite Regional Centre (CRC) Bemina, Srinagar 2021**. Since, the response of candidates for the said course is poor, so the Board has decided to provisionally select the candidates on the basis of merit secured by eligible candidates in the qualifying examination along with their preferences. The provisional merit list in this regard is annexed as **Annexure "A" to this Notification with deficiencies** and is available on official website of the Board (www.jkbopee.gov.in) only. The candidates, if any, who intent to submit representation/ remove deficiency against his/her position can do so up to **26th April, 2021 (04:00 P.M)** failing which no claim whatsoever shall be entertained under any circumstances later on. The interested candidates can deposit their representations at BOPEE Office, Jammu/Srinagar physically within the prescribed date.

Note:

1. The representations / deficient documents, if any, shall not be entertained through e-mail.
2. The provisional merit list of the candidates has been prepared on the basis of aggregate marks obtained in the qualifying examination i.e. (10+2+3) pattern. In case of tie between candidates, same has been resolved by taking into account marks obtained by candidates in qualifying examination first, followed by candidate's DOB i.e. candidate older in age is preferred first & further tie is resolved by first alphabet of candidate's name.
3. In case no objection(s) are received within the prescribed date and time by the Board, this provisional merit list shall be deemed to be treated as final.

4. The candidates who have not submitted their Domicile Certificates as on date are advised to produce the same at the time of admission to the concerned College(s).
5. Board has provisionally approved forms of candidates who have uploaded Date of birth other than 10th class examination certificate & PRC as domicile certificate but they have to produce D.O.B. certificate issued by Board & domicile certificate at the time of admission to respective College(s), if selected
6. The other terms and conditions as laid-down in the Notifications/Notices on the subject shall remain the same.
