In Notification No. 070-BOPEE of 2021 dated 08-07-2021 issued under endorsement No. BOPEE/Exam-06/2021 dated 08-07-2021, the following shall and shall be deemed to have been added under heading **Note** in point No. (iii) at Page No. 05.

**"Candidates having "Outstanding Proficiency in Sports" must submit their certificates to Secretary, J&K Sports Council for awarding points which will be then officially submitted to the Board by the Sports Council. Board shall not be responsible where a candidate fails to submit certificates to the Council or Council fails to forward points of a candidate to Board. It shall be sole responsibility of the candidate to ensure that his/her sports points are forwarded by Council to Board. The eligibility for candidates applying under CDP, JKPM, SP, EWS category shall be at par with eligibility as prescribed under OM Category candidates".**
