

## Notice No.065-BOPEE of 2021 Dated 29-08-2021

In pursuance to Notification No. 076-BOPEE of 2021 dated 16-08-2021 read with Notice No.064-BOPEE of 2021 dated 25-08-2021, the candidates, who have qualified the NEET MDS-2021, having scored the marks above cut off prescribed by the National Board of Examinations (NBE) and notified by J&K BOPEE vide Notice No. 064-BOPEE of 2021 dated 25-08-2021, and whose names figure in the Annexure, "A" to the above said Notification/Notice are hereby informed that the Board has decided to notify the online schedule for registration by the eligible candidates only belonging to Union Territories of J&K and Ladakh for preparation of the Provisional Merit List (PML), based on which the seats will be allotted subsequently on the basis of online preferences as may be submitted by the candidates:-

## Note - 1:-

- i) The online registration will commence from **01-09-2021**;
- ii) The last date of online registration will be 06-09-2021
- iii) The registration shall be made online through the BOPEE websites www.jkbopee.gov.in/jakbopee.org.

#### Note - 2:-

The candidates should upload the following documents:-

- 1. Matriculation certificate for purpose of date of birth;
- 2. BDS degree certificate;
- 3. Marks cards of all the years of BDS course;
- 4. Registration with the State /UT Dental council/DCI;
- 5. Internship completion certificate;
- Domicile certificate of UT of J&K and STK/STL certificate for UT of Ladakh as Domicile certificate;
- 7. Valid Reserved Category Certificate, wherever applicable, in terms of SRO 294 of 2005 dated 21-10-2005 read with SRO 518 dated 02-09-2019;
- 8. Difficult Area Certificate in pursuance of SRO 48 of 2018 dated 30-01-2018;
- 9. NEET BDS Score Card 2021.
- 10. DCI clearance certificate for candidates who have qualified BDS degree from outside the country.
- 11. Valid EWS certificate as per SRO 518 dated 02-09-2019.
- 12. \*NOC from Government/Competent Authority for in-service candidates seeking admission to pursue MDS Courses.
- 13. Disability certificate (applicable for candidates having disability)

#### Note - 3:-

 The cut-off date for validity of the category certificates shall be the last date for registration fixed by the BOPEE viz. 06-09-2021.



- ii) The candidates should mention their particulars carefully. The detailed instructions for filling up of online registration form is already given in the ebrochure which is available on the BOPEE websites. The candidates, in their own interest, are, therefore, advised to go through the same before filling up of the online registration form.

- \*"In-service candidates" who have qualified NEET MDS-2021 and fall in the zone of consideration will be considered subject to issuance of "NOC" by the Competent Authority. Board may have NOC certificate verified from such authorities, if it is found expedient to do so. However, they will be allowed to participate in the registration/counselling process provisionally but will be allowed to join the college only on production of NOC from the concerned authority within the stipulated date/time."
- iv) The tentative Seat Matrix shall be notified separately in due course of time, which shall be available on the website of the Board.
- v) The Board has included the name of one candidate namely Mudasir Nazir having NEET Rank 449 and with NEET-MDS Score 554 for registration of NEET-MDS counselling who has submitted his documents along with undertaking that he will not participate in All India Quota (AIQ) for the session 2021-22.

## Note - 4:-

- (1) The candidates shall have to fill the following fields correctly and as has been filled in the NEET application form:
  - a) NEET Roll No as per Admit Card.
  - b) NEET -MDS Score Card 2021.
  - c) NEET Rank.
  - d) DOB.
- (2) Mere registration of the candidates shall not confer any right on all such candidates for admission, which is subject to further check and clarification of their documents during the process of registration.
- (3) The registration of candidates and the seat matrix to be uploaded by the Board before notifying the schedule for online counselling / submission of preferences and allotment of seat(s) thereof, is subject to such change(s), as may be made by the GOI / DCI / Government of J&K / Board, from time to time.
