Consequent upon receipt of shortfall in respect of Notification No. 074-BOPEE of 2021 dated 09.08.2021 and the seats, which have remained unfilled after conclusion of second round of physical counselling held on 07.08.2021 to 09.08.2021 at BOPEE Office, Srinagar/ Jammu, it is hereby notified that the Board shall conduct mop-up round of physical counselling for up-gradation/ allotment of seats to the eligible candidates for admission to 10th based Paramedical (FMPHW/MMPHW)- Courses on 15.09.2021 at BOPEE Office, Srinagar/ Jammu simultaneously through Video Conferencing as per the following:

Date	Rank	Remarks
15.09.2021	01 to 1338	All reserved category candidates shall come for counselling in the morning from 10.30 AM to 11.30PM.
15.09.2021	01 to 1338	All Open Merit and reserved category candidates shall be called for counseling after conversion of category seat if any, remaining unfilled.

The candidates are advised to report to the BOPEE Office, Srinagar/ Jammu on **15.09.2021 at 8.30 AM to 10.30 AM** for registration and subsequent counselling.

Note: 1) One seat in Govt. AMT School, Gandhi Nagar Jammu under RBA category has been reserved as per the direction of the Hon'ble High Court, Jammu till final out of the main writ petition filled by one candidate.

2) Candidates who have been allotted seats during 1st/2nd round of physical counselling and have joined the respective Colleges/Institutions and are interested to participate in the mop-up round of counselling for upgradation are directed to bring along with the fee deposition receipt of the concerned College/ Institution positively.

The following shall be eligible to participate in the mop-up round of counselling:-

1. The candidates who have been allotted seats during second round of counselling and have joined in their respective allotted colleges/ courses.
2. The candidates who have been allotted seats during the 1st round of counselling but could not join the respective Colleges/Institutions for one or other reason.
3. The candidates who could not participate in the first and second round of up-gradation/allotment counselling for one or the other reason.
4. The reserved category seats, if any, which shall remain unfilled after conclusion of counselling of the candidates, shall be converted into open merit and accordingly allotted to the eligible candidates in order of merit and choice.
5. The reserved category candidate(s) if any, not upgraded due to non availability of his/ her choice of seat/ Institution under reserved category, can participate in further counselling as an open merit candidate on the same date as per his merit.


The following shall not be eligible to participate in the mop-up round of counselling:-

1. The candidates, who have been allotted seat(s) in the second round of counselling but failed to join the allotted Institution within the prescribed time limit fixed by the Board.

2. The candidates who have been provisionally upgraded during second round of counselling.

The other terms and conditions shall remain the same as notified in the e-Information Brochure/ Notifications/ Notices issued by the Board from time to time on the subject.
