Applications are invited from the candidates belonging to UT's of J&K/Ladakh who are eligible and desirous for admission to M.Sc Tech Courses (SKIMS) 2021 through offline mode. The selection of the candidates shall be Governed by the J&K Board of Professional Entrance Examination Act, 2002, SRO 505 of 2019 dated 20-08-2019 read with SRO 640 of 2019 dated 24- 10-2019 and the Rules and Regulations there under, JK Reservation Act, 2004 as amended vide J&K Reorganization Act, 2019, S.O 127 dated 20-04-2020, S.O 249dated:-23-07-2021 and subject to further amendments, if any, made by the Competent Authority/Govt.

Eligibility for candidates: Any candidate applying for this course:-

- a) Must be Domicile of UT of J&K /Ladakh.
- b) Should have the Minimum eligibility required for M.Sc. Tech. Degree Courses as under:-

Note:- It is mentioned here that the candidates possessing B.Sc. in Radiology Imaging Technology (Radiology/CT/MRI), B.Sc. Medical Imaging Technology, B.Sc Radiation & Imaging Technology are eligible for all the three courses in M.Sc. Radiotherapy , M.Sc. Radio diagnosis, M.Sc. Nuclear Medicine.

- (i) domicile of UT of J&K/UT of Ladakh as the case may be (domicile Certificate, if not issued, at the time of submission of Registration cum Application Form, the candidate can submit an undertaking certifying that he /she shall submit /produce the same at the time of counselling/admission). For Candidates of UT of Ladakh, ST certificate issued by the competent Authority of Ladakh shall be treated as Domicile Certificate.
- (ii) Desired qualifying marks card of the courses passed which are required by the candidate(s) to be eligible for these courses.
- (iii) Date of Birth (10th class Marks card/Diploma issued by the Board)
- (iv) Experience/work Certificate wherever required.
- (v) Valid Reserved category certificate, if any &
- (vi) Fee of Rs 1200/= to be paid through POS machine available at BOPEE office Jammu/Srinagar through debit/credit card.

The Application Form shall be available at BOPEE office Jammu/Srinagar and also annexed as Annexure "A" to this Notification which can be downloaded from official website www.jkbopee.gov.in.

However, it is for the information of all concerned that afore-titled documents as required for submission of application form shall be considered provisional and subject to change(s) vide any order as may be issued by the Government subsequently.

Note:-

The eligibility is bare minimum/provisional and shall be subject to such changes/bench marks as may be fixed by the concerned University/competent Authority. The Board shall on receipt of any such communication from the concerned authority/University notify the same, which shall govern the eligibility criteria.

Instructions:

a) No under process certificate will be accepted/entertained;

b) Original Documents as mentioned above are required to be submitted in the concerned Institution at the time of Admission.

Mode of Selection/Admission:

The Board has decided to fill up these seats on the basis of %age of marks scored by the candidates in the qualifying examination as filled in by the candidates in the Application form and on the basis of preferences filled during the time of counselling. In case two or more candidates having same Marks in B.Sc. Technology Course , then their tie shall be resolved by **3** | P age

considering their D.O B (elder in age shall be given 1st preference) & in case of further tie, 1st alphabet of the name of candidate shall be taken into the account for selection.
