

The Board vide Notification No. 098-BOPEE of 2021 dated 28-09-2021 read with Notice No. 071-BOPEE of 2021 dated 13-10-2021 invited off-line Application Forms from the eligible candidates for admission to M.Sc. Nursing Course-2021 in various institutions of UTs of J&K/ Ladakh. The Board has prepared a provisional merit list of the candidates which is annexed as **Annexure "A"** to this notification and is available on official website of the Board (www.jkbopee.gov.in) only. The candidate(s) if any, who intent to submit representation against his/her position in this merit list can do so upto 08-11-2021 (4:00 P.M) failing which no claim whatsoever shall be entertained under any circumstances. The interested candidates can submit the same at BOPEE office Jammu/ Srinagar physically. Further, the candidates who have deficiency of any required document as shown in the list are also advised to clear the same by or before 08-11-2021 positively, otherwise their candidature shall be treated as cancelled on their own risk and responsibility

1. **The representations/deficient documents, if any shall not be accepted through e-mail.**
2. The merit list of the candidates has been prepared on the basis of **aggregate marks obtained** in the qualifying examination i.e. in B.Sc. Nursing/Post Basic B.Sc Nursing. In case of tie between candidates, same shall be resolved by taking into account the date of birth of candidate's i.e candidate older in age is preferred first as already mentioned in Notification No: 098-BOPEE of 2021 dated 28-09-2021.
3. The reservation to various reserved categories including sports category is applicable in Govt. run colleges/Institutions only & not in Private colleges/Institutions.
4. Mere name figuring in Provisional Merit list annexed as Annexure "A" to this Notification does not confer any right of selection to the said course subject to further verification of documents by Board during physical round of counselling as & when held by the Board at BOPEE office Jammu/Srinagar in due course of time.
5. The intending candidates shall keep ready their **domicile certificate, Work Experience, Registration certificate etc.** issued by the competent authority along with all other original documents as required by the concerned Principals at the time of admission to their respective colleges after allotment of seats to them.
6. The candidates must remain in touch with the official website of the Board so as to be abreast of the final schedule of the counseling which shall be held **physically** at BOPEE office Jammu/Srinagar simultaneously and shall be notified separately after the submission of objections/documents, if any, received from intending candidates mentioned in the Provisional Merit List to be uploaded on the official web site of the Board www.jkbopee.gov.in.

7. In case no objections are received within the cutoff date by the Board, the Provisional Merit List shall be deemed to be treated as final.
