Consequent upon the declaration of the NEET UG-2021 result by National Testing Agency (NTA) on 01.11.2021 and with a view to update the category status and preparation of the Provisional UT Merit List (PUTML) of registered candidates, it is hereby notified that the candidates who have secured the minimum qualifying marks in NEET UG-2021 shall be required to register themselves and upload the following documents online w.e.f. **11-01-2022 to 16-01-2022 on website of BOPEE ([www.jkbopee.gov.in](http://www.jkbopee.gov.in))**.

1. NEET-UG score card.
2. 10+2 marks card.
3. Domicile Certificate for candidates belonging to the UT of J&K and ST Category certificate in respect of candidates belonging to the UT of Ladakh.
4. Category Certificate, wherever required.
5. Date of Birth Certificate (Matriculation).
6. The candidates belonging to the UT of Ladakh are required to upload Compulsory Service Bond (which shall available in information Brochure to be uploaded by the Board on the official website [www.jkbopee.gov.in](http://www.jkbopee.gov.in)) that he/she will serve in UT of Lakadh for the prescribed period as may be decided by UT of Ladakh after completing MBBS/BDS degree.

The tentative NEET score list of candidates of J&K, who have appeared in the NEET-UG 2021 has already been notified vide Notification No. 127-BOPEE of 2021 dated 15-11-2021 & Notice No. 082-BOPEE of 2021 dated 02-12-2021, which are available on the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) only. Mobile phones should not be used for registration purposes for uploading of documents, as software will not accept the same.

The e-Information Brochure for NEET UG-2021 Courses shall be uploaded by the BOPEE on its website in due course of time. The candidates are accordingly advised to go through the said e-Brochure before registration.

#### **REGISTRATION SCHEDULE**

- i) **Online registration/uploading of documents from 11-01-2022 to 16-01-2022.**
- ii) **Provisional merit list to be notified tentatively on 19-01-2022.**
- iii) **Online filling up of Preference Forms with tentative seat matrix shall be uploaded in due course of time, therefore, the candidates in their own interest are advised to remain in touch with website of the BOARD Viz. [www.jkbopee.gov.in](http://www.jkbopee.gov.in).**

#### **NOTE:-**

1. No under process certificate shall be entertained;
2. The Board shall entertain only such category certificates which have been issued by the concerned Competent Authority up-to the last date of registration. No certificate issued after the prescribed cut-off date (16-01-2022) shall be entertained under any circumstances.
3. The candidate must fulfill all other criteria as laid down in the NEET-UG 2021 Information Bulletin of NTA and Information Brochure of BOPEE in respect of NEET-UG, 2021 courses;
4. Any candidate found in-eligible at any point of time shall not be allowed to participate in the counseling process notwithstanding the registration / NEET qualifying score;
5. The candidates should upload their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them; whenever required by the Board.
6. Candidates, in their own interest, are advised not to share e-mail password with other candidate/person;
7. Board shall not be responsible for any mistake committed by the candidates, while making registration;
8. After completion of the registration process, Board shall notify the Provisional UT Merit List (PUTML) of all the eligible candidates, which shall be used for online counseling by the candidates at the time of filling up of the preferences based on which allotment of seat shall be made;

9. Any candidate, who falls within qualifying merit but does not register himself/herself or does not upload the documents or the documents uploaded are deficient shall not be considered for allotment of any seat;
10. The candidates, in their own interest, are advised to go through the e-Information Brochure which shall be available as and when uploaded by Board on its website viz. [www.jkbopee.gov.in](http://www.jkbopee.gov.in) before commencement of online registration and go **through the technical and other instructions before registering themselves;**
11. Since the admission in the Professional Colleges is time bound, therefore, the candidates should not wait for last date of registration as it may even be detrimental to their interest;
12. The Persons with Disability (PWD) candidates are directed to upload and submit their valid PWD certificate in BOPEE Office Srinagar / Jammu, physically also up-to 16-01-2022,(3.00 PM) positively.
13. The candidates shall have to fill in following fields which are mandatory in nature and without which they cannot proceed further:-
  - i. **Student NEET Roll No.**
  - ii. **NEET Score.**
  - iii. **NEET Rank.**
  - iv. **Date of Birth.**
  - v. **Gender**
  - vi. **Category, if any.**
  - vii. **Upload Compulsory Service Bond on prescribed format by the candidates of UT of Ladakh**
14. **The candidates, who intend to participate against NRI/HM Quota seats in ASCOMS, Jammu/IDS, Sehora shall also have to register themselves online and submit all such documents offline in the Board office up to the date as may be notified by the Board separately;**
15. Candidates are again advised to remain in touch with the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) and should not wait for publication of Notices/Notifications in the News Papers, which may get delayed for the reason beyond the control of the BOPEE.
