It is notified for information of all the eligible NEET-UG 2021 candidates who have already registered themselves with BOPEE that the process for submission of online preferences for allotment of College/Courses shall start w.e.f **02-02-2022 to 05-02-2022 (mid-night)**. However, one day mock exercise for filling up of online preferences shall be available for eligible candidates on 01-02-2022 (till mid night) only. As the Board has not received any objections / representations up to 27-01-2022 (till 02:00 P.M), against the provisional UT merit list of J&K/ Ladakh as notified vide Notification No. 006-BOPEE of 2022 dated 24-01-2022, the said list shall be treated as final. Seat matrix shall be available on BOPEE website before the start of final online counseling process i.e.02-02-2022.

Further, the candidates shall have to pay online counselling fee of Rs1500/- as already mentioned in the e-Information Brochure of NEET-UG 2021.

The other terms and conditions shall remain the same as mentioned in the e-Information Brochure and the Notifications/Notices issued on the subject from time to time.
