
## Notice No.005-BOPEE of 2022

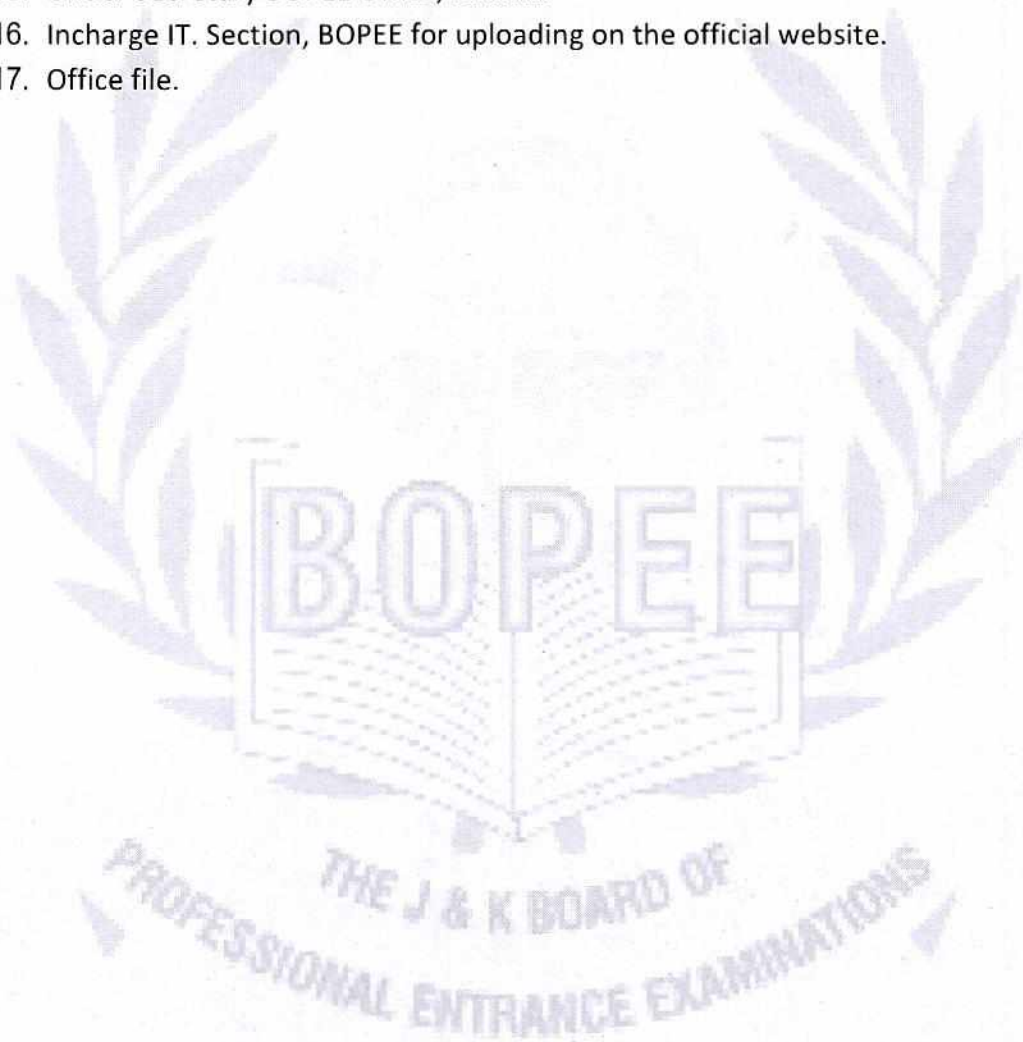




