



Online Registration of NEET UG-2021 qualified candidates of UT of Subject: J&K/Ladakh for admission to Ayush and BPT Courses-2021.

Notification No. 017-BOPEE of 2022 Dated 28-02-2022

Consequent upon declaration of the NEET UG-2021 result by the National Testing Agency on 01-11-2021, and to update the category status vis a vis preparation of the Provisional UT Merit List of registered candidates for admission to BAMS/BUMS/BPT courses 2021, it is hereby notified that the candidates who have secured the minimum qualifying marks in NEET UG -2021 shall be required to register themselves and upload the following documents with effect from 03-03-2022 to 07 -03-2022: -

- (i) NEET UG score card 2021
- (ii) 10+2 marks card.
- (iii) Domicile Certificate of UT of J&K (ST Category Certificate in respect of candidates belonging to the UT of Ladakh).
- (iv) Category Certificate, wherever required.
- (v) Date of Birth Certificate (Matriculation).

The cut-off score for different categories as notified by NTA is as under:-

- (a) Open Merit (including EWS/JKPM/Child of PMF/CDP/Sports) =138 (50th Percentile)
- (b) Open Merit/EWS-Handicapped/PWD

- =122 (45thPercentile)
- =108 (40th Percentile)
- (c) SC/ST/RBA/ALC/IB/OSC/PSP(For J&K/ Ladakh) (d) SC/ST/RBA/ALC/IB/OSC/PSP-Handicapped/PWD
- =108 (40th Percentile)

The tentative NEET Score list of candidates of J&K, who have appeared in the NEET UG 2021 has already been notified by the Board vide Notification No.127-BOPEE of 2021 dated 15.11.2021 and Notice No 082-BOPEE of 2021 dated 02.12.2021, which are available on the BOPEE website viz www.jkbopee.gov.in only. Mobile phones should not be used for registration purposes for uploading of documents, as software will not accepted the same.

The e-Information Brochure for NEET UG BAMS/BUMS/BPT 2021 courses has already been uploaded on website of the Board .The candidates are advised to go through the brochure before registration. The tentative schedule for registration etc. is as under:

- Online registration/uploading of documents: 03-03-2022 to 07-03-2022
- Notifying of Tentative Provisional Merit List: 09-03-2022.
- Online filling up of Preference Forms shall be notified separately.

Note.

- i. No under process certificates shall be entertained.
- The category certificates issued only up to the last date of registration shall be entertained.
 Any certificate issued after the registration date shall not be entertained by the Board under any circumstances.
- iii. The candidate must fulfill all the criteria as laid down in the NEET-UG 2021 information brochure of the NTA and Information Brochure of BOPEE in respect of NEET UG,2021 courses;
- iv. Any candidate found ineligible at any point of time shall not be allowed to participate in the counselling process notwithstanding the registration/NEET qualifying score fixed by the Ministry of Ayush; Government of India;
- The candidates should upload their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them; whenever required by the Board;
- vi. Candidates in their own interest, are advised not to share login password with other candidate/ person;
- vii. Board shall not be responsible for any mistake committed by the candidates, while making registration;
- viii. After completion of the registration process, Board shall notify the provisional UT Merit List of all the candidates, which shall be used for Online or Offline counseling (as may be decided by the Board) by the candidates (filling up of the preferences) based on which allotment of seat shall be made;
- ix. Any candidate, who falls within the qualifying merit but does not register himself/herself or does not upload the documents or the documents uploaded are deficient shall not be considered for allotment of any seat;
- x. The competing candidates, in their own interest, are advised to go through the einformation brochure which is available on website of the Board viz <u>www.jkbopee.gov.in</u> and go through the technical and other instructions before registering themselves;
- xi. Since the admissions in the Professional Colleges is a time bound process, the candidates should not wait for last date of registration as it may be detrimental to the interest of the candidate(s);
- xii. The candidates shall have to fill the following fields during registration which are mandatory in nature and without which they cannot proceed further:-
 - 1. Student NEET Roll No.
 - 2. NEET Score.
 - 3. NEET Rank.
 - 4. Date of Birth.
 - 5. Gender.
 - 6. Category, if any,

The candidates who are already registered for NEET MBBS/BDS courses 2021 and whose name(s) are already available in PML notified vide Notification NO:006-BOPEE of 2021 dated:24-01-2021 need not register again.

The candidates are advised to remain in touch with the BOPEE Website (<u>www.jkbopee.gov.in</u>) and should not wait for publication of Notices/Notifications in the Newspapers, which may get delayed for the reason beyond the control of the Board.
