In pursuance of Notification No. 052-BOPEE of 2022 dated 02-08-2022, whereunder the Board has notified the provisional merit list of eligible candidates who have applied for admission to Post-Basic B. Sc. Nursing Course-2022, and advised the candidates to submit objections, if any, against their positions mentioned in the Annexure "A" to the said notification upto 09-08-2022. It was also notified that in case no objections are received within the prescribed date, the provisional merit shall be deemed to be final. 1. Candidates shall have to report at BOPEE offices Jammu/Srinagar Physically for Registration/Attendance between **08:00 A.M to 10:00 A.M.**
2. The Board reserves the right to notify any changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
3. Candidates are advised to bring along their Domicile certificates issued by Competent Authority and other relevant certificates/ documents including Marks Cards of all 3/4 years as applicable for the said course to be presented at the time of counselling.

4. The seat matrix shall be uploaded on website of the Board separately in due course of time before counselling.
5. For latest updates related to the counseling, the candidates are advised to remain in touch with the Website of the Board (www.jkbopee.gov.in)
6. Any candidate who may not be able to attend the counseling personally owing to a valid reason can authorize a person (through Authority Letter-on prescribed format) from his/her family member to participate in the counseling on his/her behalf at BOPEE offices Jammu/Srinagar on the day/date of counseling as per his/her Rank.
7. The candidates provisionally selected for this course are advised to contact concerned College/Institute for admission and other requisite formalities.
